On page 1, in line 2, strike "<u>Preference and</u>"; in line 13, strike "<u>the State or</u>"; strike beginning with "<u>prohibiting</u>" in line 14 down through "<u>regulations</u>;" in line 17; in line 18, strike "<u>a</u>"; in line 19, strike "<u>term</u>;" and substitute "<u>terms</u>; providing for the <u>termination of this Act</u>;"; and in lines 20 and 21, strike "<u>preferences and</u>".

On page 2, in line 2, strike "<u>14-413</u>" and substitute "<u>12-110</u>".

AMENDMENT NO. 2

On page 2, in line 23, strike "<u>14-413.</u>" and substitute "<u>12-110.</u>"; and in line 24, after "<u>(A)</u>" insert "<u>(1)</u>"; in the same line, strike "<u>, "PUBLIC</u>" and substitute "<u>THE</u> FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(2) "PUBLIC";

in lines 25, 26, 27, 28, and 29, strike "(1)", "(2)", "(3)", "(4)", and "(5)", respectively, and substitute "(I)", "(III)", "(III)", "(IV)", and "(V)", respectively; and after line 29, insert:

"(3) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH, "SERVICES" HAS THE MEANING STATED IN § 11-101(T) OF THIS ARTICLE.

(II) "SERVICES" INCLUDES:

1. <u>CONSTRUCTION-RELATED SERVICES</u>;

AMENDMENT NO. 3

On page 3, in line 6, strike "ANTICIPATES THAT THE BIDDER"; in line 7, after "CONTRACTOR" insert "THAT"; in line 8, strike "WILL" and substitute "HAS PLANS, AT THE TIME THE BID IS SUBMITTED, TO"; and in lines 9, 11, and 14, in each instance, strike "THE STATE OR".

On pages 3 and 4, strike in their entirety the lines beginning with line 16 on page 3 through line 7 on page 4, inclusive.

AMENDMENT NO. 4

On page 5, in line 23, after "2012." insert "It shall remain effective for a period of 3 years and, at the end of September 30, 2015, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.".
