Teachers' Retirement and Pension Systems – Reemployment of Retirees – Maryland School for the Deaf Exemption

4 FOR the purpose of exempting from a certain offset of a retirement allowance certain $\mathbf{5}$ retirees of the Teachers' Retirement System or the Teachers' Pension System 6 who are employed by the Maryland School for the Deaf; providing that the 7 superintendent of the Maryland School for the Deaf may employ a certain number of certain retirees who will not be subject to a certain offset of a 8 9 retirement allowance; requiring that the superintendent of the Maryland School for the Deaf is responsible for certain reimbursements under certain 10 11 circumstances; requiring the superintendent of the Maryland School for the Deaf to submit certain reports to the Board of Trustees for the State Retirement 12 and Pension System and the Superintendent of the State Department of 13Education in a certain manner and by a certain date; and generally relating to 14 15the reemployment of retirees in the teachers' retirement and pension systems.
