1 AN ACT concerning

2 **Public Safety – Elevator Safety Review Board – Membership**

3 FOR the purpose of altering the membership of the Elevator Safety Review Board to
4 add a member representing the elevator interior renovation industry or who is a
5 licensed contractor other than an elevator contractor; and generally relating to
6 the membership of the Elevator Safety Review Board.

7 BY repealing and reenacting, with amendments,

10 Annotated Code of Maryland
11 (2003 Volume and 2011 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 12–820.

16 (a) (1) The Board consists of the following **[nine]** TEN members:

17 (i) as an ex officio member, the Commissioner; and

1 (ii) [eight] NINE members appointed by the Governor with the
2 advice of the Secretary and with the advice and consent of the Senate.

3 (2) Of the [eight] NINE appointed members of the Board:

4 (i) one shall represent a major elevator manufacturing
5 company or its authorized representative;

6 (ii) one shall represent an elevator servicing company;

7 (iii) one shall represent the architectural design profession;

8 (iv) one shall represent a municipal corporation in the State;

9 (v) one shall represent a building owner or manager;

10 (vi) one shall represent labor involved in the installation,
11 maintenance, and repair of elevators; [and]

12 (VII) ONE SHALL:

13 1. REPRESENT THE ELEVATOR INTERIOR
14 RENOVATION INDUSTRY; ~~AND~~ OR

15 2. BE A CONTRACTOR LICENSED BY THE BOARD,
16 OTHER THAN AN ELEVATOR CONTRACTOR; AND

17 [(vii)] (VIII) two shall be members of the public.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2012.
