2 **State Employees' Retirement and Pension Systems – Eligible Employees – St.**  
3 **Mary's Nursing Center, Inc.**

4 FOR the purpose of authorizing certain employees of the St. Mary's Nursing Center,  
5 Inc. to continue to participate in the State employees' retirement and pension  
6 systems; updating the name of the St. Mary's County Nursing Home in a  
7 certain list of governmental units eligible for participation in the employees'  
8 systems; and generally relating to the participation of certain St. Mary's  
9 Nursing Center, Inc. employees in the State employees' retirement and pension  
10 systems.

11 **SUBTITLE ARE THOSE EMPLOYEES WHO WERE MEMBERS OF THE EMPLOYEES’**  
12 **RETIREMENT SYSTEM OR THE EMPLOYEES’ PENSION SYSTEM AS EMPLOYEES**  
13 **OF THE ST. MARY’S COUNTY NURSING HOME ON JANUARY 17, 1996.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
15 July 1, 2012.
