A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loans of 2002 and 2009 – Montgomery**
3 **County – MacDonald Knolls Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loans of 2002
5 and 2009 to extend the deadline for the Board of Directors of CHI Centers, Inc.
6 to present evidence that a matching fund will be provided for a certain grant;
7 requiring that the Board of Public Works expend or encumber the proceeds of
8 the loans by June 1, 2014; making this Act an emergency measure; and
9 generally relating to amending the Maryland Consolidated Capital Bond Loans
10 of 2002 and 2009.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
23 MARYLAND, That:

1 (OO) MacDonald Knolls Center. Provide a grant to the Board of
 2 Directors of CHI Centers, Inc. for the construction,
 3 reconstruction, repair, renovation, and capital equipping of
 4 the MacDonald Knolls Center, located in Silver Spring. The
 5 proceeds of the loan must be encumbered by the Board of
 6 Public Works or expended for the purposes provided in this
 7 Act no later than June 1, [2011] **2014**
 8 (Montgomery County) 175,000

Chapter 485 of the Acts of 2009

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
11 MARYLAND, That:

12 (3) ZA02 HOUSE OF DELEGATES LEGISLATIVE INITIATIVES

13 (AI) MacDonald Knolls Center. Provide a grant equal to the lesser
 14 of (i) \$100,000 or (ii) the amount of the matching fund
 15 provided, to the Board of Directors of CHI Centers, Inc. for the
 16 repair, renovation, reconstruction, and capital equipping of
 17 the MacDonald Knolls Center, located in Silver Spring.
 18 **NOTWITHSTANDING SECTION 1(5) OF THIS ACT, THE**
 19 **GRANTEE HAS UNTIL JUNE 1, 2013, TO PRESENT**
 20 **EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED.**
 21 **NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THE**
 22 **PROCEEDS OF THE LOAN MUST BE EXPENDED OR**
 23 **ENCUMBERED BY THE BOARD OF PUBLIC WORKS FOR**
 24 **THE PURPOSES PROVIDED IN THIS ACT NO LATER THAN**
 25 **JUNE 1, 2014** (Montgomery County) 100,000

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
27 measure, is necessary for the immediate preservation of the public health or safety,
28 has been passed by a yea and nay vote supported by three-fifths of all the members
29 elected to each of the two Houses of the General Assembly, and shall take effect from
30 the date it is enacted.
