## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loans of 2002 and 2009 – Montgomery**  
3 **County – MacDonald Knolls Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loans of 2002  
5 and 2009 to extend the deadline for the Board of Directors of CHI Centers, Inc.  
6 to present evidence that a matching fund will be provided for a certain grant;  
7 requiring that the Board of Public Works expend or encumber the proceeds of  
8 the loans by June 1, 2014; making this Act an emergency measure; and  
9 generally relating to amending the Maryland Consolidated Capital Bond Loans  
10 of 2002 and 2009.

11 BY repealing and reenacting, with amendments,  
12 Chapter 290 of the Acts of the General Assembly of 2002, as amended by  
13 Chapter 707 of the Acts of the General Assembly of 2009  
14 Section 1(3) Item ZA00(OO)

15 BY repealing and reenacting, with amendments,  
16 Chapter 485 of the Acts of the General Assembly of 2009  
17 Section 1(3) Item ZA02(AI)

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
2 MARYLAND, That:

3 (3) ZA00 MISCELLANEOUS GRANT PROGRAMS

4 (OO) MacDonald Knolls Center. Provide a grant to the Board of  
5 Directors of CHI Centers, Inc. for the construction,  
6 reconstruction, repair, renovation, and capital equipping of  
7 the MacDonald Knolls Center, located in Silver Spring. The  
8 proceeds of the loan must be encumbered by the Board of  
9 Public Works or expended for the purposes provided in this  
10 Act no later than June 1, [2011] 2014  
11 (Montgomery County) ..... 175,000

12 Chapter 485 of the Acts of 2009

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That:

15 (3) ZA02 HOUSE OF DELEGATES LEGISLATIVE INITIATIVES

16 (AI) MacDonald Knolls Center. Provide a grant equal to the lesser  
17 of (i) \$100,000 or (ii) the amount of the matching fund  
18 provided, to the Board of Directors of CHI Centers, Inc. for the  
19 repair, renovation, reconstruction, and capital equipping of  
20 the MacDonald Knolls Center, located in Silver Spring.  
21 **NOTWITHSTANDING SECTION 1(5) OF THIS ACT, THE**  
22 **GRANTEE HAS UNTIL JUNE 1, 2013, TO PRESENT**  
23 **EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED.**  
24 **NOTWITHSTANDING SECTION 1(7) OF THIS ACT, THE**  
25 **PROCEEDS OF THE LOAN MUST BE EXPENDED OR**  
26 **ENCUMBERED BY THE BOARD OF PUBLIC WORKS FOR**  
27 **THE PURPOSES PROVIDED IN THIS ACT NO LATER THAN**  
28 **JUNE 1, 2014** (Montgomery County) ..... 100,000

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency  
30 measure, is necessary for the immediate preservation of the public health or safety,  
31 has been passed by a yea and nay vote supported by three-fifths of all the members  
32 elected to each of the two Houses of the General Assembly, and shall take effect from  
33 the date it is enacted.
