CHAPTER _____

1 AN ACT concerning

Baltimore City Community Enhancement Transit–Oriented Development Fund

FOR the purpose of establishing the Baltimore City Community Enhancement 4 Transit-Oriented Development Fund for certain purposes; providing that the $\mathbf{5}$ 6 Fund is a special, nonlapsing fund; providing for the contents and uses of the 7Fund; requiring providing that a certain portion of certain revenues from 8 certain projects and certain other money <u>shall</u> be paid into the Fund <u>under</u> 9 *certain circumstances*; requiring the Comptroller to pay certain money from the 10 Fund to the Mayor and City Council of Baltimore City in a certain manner; authorizing the Mayor and City Council to use or make awards of money 11 12 received from the Fund for certain purposes; requiring the State Treasurer to 13invest the money in the Fund in a certain manner; adding the Fund to the list of 14 exceptions to the requirement that the earnings of special funds accrue to the
