BY repealing and reenacting, with amendments, Article 2B – Alcoholic Beverages Section 7–101(d) Annotated Code of Maryland (2011 Replacement Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article 2B - Alcoholic Beverages 7-101.A special Class C beer, wine and liquor license entitles the (d) (1)holder to exercise any of the privileges conferred by this class of license for the use of any person holding a bona fide entertainment conducted by a club, society, or association at the place described for a period not exceeding seven consecutive days, upon the payment of a fee of \$15 per day.
