## **Elections – Baltimore City – Election Dates**

3 FOR the purpose of altering the dates of certain elections for municipal offices in Baltimore City; specifying the terms term of municipal officers in Baltimore City 4 who were elected in a certain year; providing for a delayed effective date; and  $\mathbf{5}$ 6 generally relating to elections in Baltimore City.

- 12SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
