A BILL ENTITLED

1 AN ACT concerning

2 **Regulated Firearms – License Issued by Delaware, Pennsylvania, Virginia, or**
3 **West Virginia – Reciprocity**

4 FOR the purpose of specifying that a license issued by Delaware, Pennsylvania,
5 Virginia, or West Virginia to an individual to carry a regulated firearm,
6 including a concealed regulated firearm, is valid in Maryland; and generally
7 relating to regulated firearms.

8 BY repealing and reenacting, without amendments,

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Public Safety**

1 (p) "Regulated firearm" means:

2 (1) a handgun; or

3 (2) a firearm that is any of the following specific assault weapons or
4 their copies, regardless of which company produced and manufactured that assault
5 weapon:

6 (i) American Arms Spectre da Semiautomatic carbine;

7 (ii) AK-47 in all forms;

8 (iii) Algimec AGM-1 type semi-auto;

9 (iv) AR 100 type semi-auto;

10 (v) AR 180 type semi-auto;

11 (vi) Argentine L.S.R. semi-auto;

12 (vii) Australian Automatic Arms SAR type semi-auto;

13 (viii) Auto-Ordnance Thompson M1 and 1927 semi-automatics;

14 (ix) Barrett light .50 cal. semi-auto;

16 (xi) Bushmaster semi-auto rifle;

7 **VIRGINIA TO AN INDIVIDUAL TO CARRY A REGULATED FIREARM, INCLUDING A**
8 **CONCEALED REGULATED FIREARM, IS VALID IN THIS STATE.**

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 October 1, 2012.
