- 1 (a) Except as otherwise provided in this title, a person may not practice, 2 attempt to practice, or offer to practice psychology in this State unless licensed by the 3 Board.
- 4 (b) Each violation of this section is a separate offense.
- 5 18–402.
- 6 (a) Unless authorized to practice psychology under this title, a person may 7 not represent to the public by title, by description of services, methods, or procedures, 8 or otherwise, that the person is authorized to practice psychology in this State.
- 9 (b) Unless authorized or permitted to do so by this title, a person may not 10 use as a title or describe the services the person provides by use of the words "psychological", "psychologist", or "psychology".

- (A) A person who violates any provision of this subtitle is guilty of a misdemeanor and on conviction is subject to a fine not exceeding [\$500] **\$10,000** or imprisonment in jail not exceeding [6 months] **1 YEAR** or both.
