A BILL ENTITLED

1 AN ACT concerning

2 Creation of a State Debt – Baltimore City – PMO Community Youth Center

3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$300,000, 4 the proceeds to be used as a grant to the Payne Memorial Outreach, Inc. for $\mathbf{5}$ certain development or improvement purposes; providing for disbursement of 6 the loan proceeds, subject to a requirement that the grantee provide and expend 7 a matching fund; prohibiting the use of the loan proceeds or matching fund for 8 sectarian religious purposes; establishing a deadline for the encumbrance or 9 expenditure of the loan proceeds; and providing generally for the issuance and sale of bonds evidencing the loan. 10

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12 MARYLAND, That:

13The Board of Public Works may borrow money and incur indebtedness on (1)behalf of the State of Maryland through a State loan to be known as the Baltimore 1415City – PMO Community Youth Center Loan of 2012 in a total principal amount equal 16 to the lesser of (i) \$300,000 or (ii) the amount of the matching fund provided in 17accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale, 18and delivery of State general obligation bonds authorized by a resolution of the Board 19of Public Works and issued, sold, and delivered in accordance with §§ 8–117 through 208-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.

21 (2) The bonds to evidence this loan or installments of this loan may be sold 22 as a single issue or may be consolidated and sold as part of a single issue of bonds 23 under § 8–122 of the State Finance and Procurement Article.

(3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and first shall be applied to the payment of the expenses of issuing, selling, and delivering the bonds, unless funds for this purpose are otherwise provided, and then shall be credited on the books of the Comptroller and expended, on approval by the

1 Board of Public Works, for the following public purposes, including any applicable 2 architects' and engineers' fees: as a grant to the Payne Memorial Outreach, Inc. 3 (referred to hereafter in this Act as "the grantee") for the design, construction, 4 renovation, and reconstruction of the Payne Memorial Outreach Community Youth 5 Center, located in Baltimore.

6 (4) An annual State tax is imposed on all assessable property in the State in 7 rate and amount sufficient to pay the principal of and interest on the bonds, as and 8 when due and until paid in full. The principal shall be discharged within 15 years 9 after the date of issuance of the bonds.

10 (5)Prior to the payment of any funds under the provisions of this Act for the 11 purposes set forth in Section 1(3) above, the grantee shall provide and expend a 12matching fund. No part of the grantee's matching fund may be provided, either 13directly or indirectly, from funds of the State, whether appropriated or unappropriated. No part of the fund may consist of real property or funds expended 1415prior to the effective date of this Act. The fund may consist of in kind contributions. In 16 case of any dispute as to the amount of the matching fund or what money or assets 17may qualify as matching funds, the Board of Public Works shall determine the matter and the Board's decision is final. The grantee has until June 1, 2014, to present 18 evidence satisfactory to the Board of Public Works that a matching fund will be 1920provided. If satisfactory evidence is presented, the Board shall certify this fact and the 21amount of the matching fund to the State Treasurer, and the proceeds of the loan 22equal to the amount of the matching fund shall be expended for the purposes provided 23in this Act. Any amount of the loan in excess of the amount of the matching fund 24certified by the Board of Public Works shall be canceled and be of no further effect.

25No portion of the proceeds of the loan or any of the matching funds may (6)26be used for the furtherance of sectarian religious instruction, or in connection with the 27design, acquisition, or construction of any building used or to be used as a place of 28sectarian religious worship or instruction, or in connection with any program or 29department of divinity for any religious denomination. Upon the request of the Board 30 of Public Works, the grantee shall submit evidence satisfactory to the Board that none 31of the proceeds of the loan or any matching funds have been or are being used for a 32 purpose prohibited by this Act.

(7) The proceeds of the loan must be expended or encumbered by the Board of Public Works for the purposes provided in this Act no later than June 1, 2019. If any funds authorized by this Act remain unexpended or unencumbered after June 1, 2019, the amount of the unencumbered or unexpended authorization shall be canceled and be of no further effect. If bonds have been issued for the loan, the amount of unexpended or unencumbered bond proceeds shall be disposed of as provided in § 8–129 of the State Finance and Procurement Article.

40 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 41 June 1, 2012.
