## State Government - E-Verify Program

3 FOR the purpose of declaring that it is the public policy of the State to restrict and deter the use of unauthorized aliens in the performance of public contracts and 4 5 grants in the State; specifying criteria for mandatory registration in a certain 6 federal E-Verify program for certain contractors and grantees; prohibiting 7 noncompliant persons or entities from performing certain contracts; imposing 8 certain requirements on certain subcontractors; authorizing the Commissioner 9 of Labor and Industry to assess certain penalties for a violation of this Act; providing that the penalties imposed under the authority of this Act do not 10 apply to certain contractors and grantees under certain circumstances; defining 11 12certain terms; and generally relating to the employment of unauthorized aliens and the federal E-Verify program. 13

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

22 MARYLAND, That the Laws of Maryland read as follows:

## **Article - State Finance and Procurement**

TITLE 20. USE OF THE FEDERAL E-VERIFY PROGRAM TO PREVENT THE

- 4 (B) "AGENCY" MEANS ANY AGENCY, DEPARTMENT, BOARD,
- 5 COMMISSION, OR OTHER ENTITY OF THE STATE OR A POLITICAL SUBDIVISION
- 6 OF THE STATE THAT CONTRACTS WITH CONTRACTORS OR ISSUES GRANTS OF
- 7 PUBLIC MONEY TO ELIGIBLE RECIPIENTS.
- 8 (C) "COMMISSIONER" MEANS THE COMMISSIONER OF LABOR AND 9 INDUSTRY.
- 10 **(D)** "E-VERIFY PROGRAM" MEANS:
- 11 (1) THE FEDERAL E-VERIFY PROGRAM THAT PROVIDES
- 12 ELECTRONIC VERIFICATION OF WORK AUTHORIZATION THAT IS JOINTLY
- 13 OPERATED BY THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY
- 14 AND THE SOCIAL SECURITY ADMINISTRATION; OR
- 15 (2) A SUCCESSOR PROGRAM THAT IS AUTHORIZED BY THE

- 20 (E) "UNAUTHORIZED ALIEN" MEANS AN ALIEN WHO DOES NOT HAVE
- 21 THE LEGAL RIGHT OR AUTHORIZATION UNDER FEDERAL LAW TO WORK IN THE
- 22 UNITED STATES AS DESCRIBED IN 8 U.S.C. § 1324A(H)(3).

- 24 IT IS THE PUBLIC POLICY OF THE STATE THAT A GOVERNMENT AGENCY
- 25 OR GOVERNMENT CONTRACTOR MAY NOT PERFORM OR ALLOW THE
- 26 PERFORMANCE OF A PUBLIC CONTRACT IN THE STATE NOR PROVIDE FOR A
- 27 GRANT OF STATE MONEY IF UNAUTHORIZED ALIENS ARE TO BE UTILIZED IN ANY

- 3 (2) ANY SUBCONTRACTOR OF A CONTRACTOR DESCRIBED UNDER 4 ITEM (1) OF THIS SUBSECTION; AND
- 5 (3) A PERSON WHO RECEIVES A GRANT OF MONEY FROM THE 6 STATE OR A POLITICAL SUBDIVISION OF THE STATE.
- 7 (B) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS 8 SUBSECTION, A PERSON OR ENTITY SUBJECT TO THIS SECTION SHALL REGISTER 9 AND PARTICIPATE IN THE E-VERIFY PROGRAM.
- 10 (2) THE FOLLOWING CONTRACTS OR GRANTS ARE EXEMPT FROM PARAGRAPH (1) OF THIS SUBSECTION:
- 12 (I) A CONTRACT OR SUBCONTRACT OF LESS THAN \$100,000, INCLUDING A SUBCONTRACT WITH AN INDEPENDENT CONTRACTOR;
- 14 (II) A GRANT OF LESS THAN \$100,000;
- (III) A CONTRACT OR GRANT UNDER WHICH THE WORK IS
  PERFORMED ENTIRELY BY INDIVIDUALS NOT SUBJECT TO THE EMPLOYMENT
  VERIFICATION REQUIREMENTS OF 8 U.S.C. § 1324A(B);
- 18 (IV) A CONTRACT FOR THE SUPPLY OF:
- 19 1. COMMERCIALLY AVAILABLE OFF-THE-SHELF
- 20 ITEMS; OR
- 2. ITEMS THAT ARE SOLD IN SUBSTANTIAL
- 22 QUANTITIES IN THE COMMERCIAL MARKETPLACE AND OFFERED TO THE STATE
- 23 IN THE SAME FORM THAT THEY ARE AVAILABLE IN THE COMMERCIAL
- 24 MARKETPLACE; AND
- 25 (V) A CONTRACT FOR FOOD AND AGRICULTURAL PRODUCTS
- 26 SHIPPED AS BULK CARGO, INCLUDING GRAINS, OILS, PRODUCE, AND SIMILAR
- 27 COMMODITIES.

- 29 (A) BEFORE THE APPROVAL OF ANY PAYMENT BY A CONTRACTING
- 30 AGENCY TO A PERSON REQUIRED TO REGISTER FOR AND PARTICIPATE IN THE

- 2 CONTRACTING AGENCY UNDER PENALTY OF PERJURY THAT EMPLOYMENT
- 3 AUTHORIZATION HAS BEEN MADE FOR ALL EMPLOYEES HIRED DURING THE
- 4 PERFORMANCE PERIOD OF THE CONTRACT OR GRANT.
- 5 (B) A PERSON SUBJECT TO THIS TITLE MAY NOT EMPLOY OR CONTINUE
- 6 TO EMPLOY AN INDIVIDUAL, OR CONTRACT INDEPENDENTLY WITH AN
- 7 INDIVIDUAL, TO PERFORM WORK OR PROVIDE SERVICES UNDER THAT
- 8 CONTRACT, IF THE INDIVIDUAL IS NOT LAWFULLY ELIGIBLE FOR EMPLOYMENT
- 9 IN THE UNITED STATES, AS DETERMINED BY VERIFICATION OF THE
- 10 INDIVIDUAL'S STATUS THROUGH THE E-VERIFY PROGRAM.
- 11 (C) AS A CONDITION OF A CONTRACT, A PERSON SUBJECT TO THIS
- 12 TITLE SHALL REQUIRE THAT THE PRIME CONTRACTOR INCLUDE IN EVERY
- 13 SUBCONTRACT EXECUTED UNDER THE CONTRACT A PROVISION REQUIRING THE
- 14 SUBCONTRACTOR, INCLUDING AN INDIVIDUAL INDEPENDENT CONTRACTOR, TO
- 15 COMPLY WITH THE REQUIREMENTS IMPOSED BY THIS TITLE ON THE PRIME
- 16 CONTRACTOR.

- 18 (A) IF A CONTRACTOR, SUBCONTRACTOR, OR GRANTEE VIOLATES ANY
- 19 PROVISION OF THIS TITLE, THE COMMISSIONER MAY ASSESS A CIVIL PENALTY

- 21 (1) UP TO \$1,000 FOR EACH EMPLOYEE WHO IS NOT LAWFULLY
- 22 ELIGIBLE FOR EMPLOYMENT; OR
- 23 (2) IF THE COMMISSIONER DETERMINES THAT THE
- 24 CONTRACTOR, SUBCONTRACTOR, OR GRANTEE KNOWINGLY VIOLATED THIS
- 25 TITLE OR ACTED WITH RECKLESS DISREGARD FOR THE REQUIREMENTS OF THIS
- 26 **TITLE:**
- 27 (I) UP TO \$5,000 FOR EACH EMPLOYEE WHO IS NOT
- 28 LAWFULLY ELIGIBLE FOR EMPLOYMENT FOR THE FIRST OR SECOND VIOLATION;
- 29 **OR**
- 30 (II) UP TO \$20,000 FOR EACH EMPLOYEE WHO IS NOT
- 31 LAWFULLY ELIGIBLE FOR EMPLOYMENT FOR THE THIRD OR SUBSEQUENT
- 32 VIOLATION.
- 33 (B) A CONTRACTOR OR GRANTEE IS NOT SUBJECT TO CIVIL PENALTIES
- 34 UNDER THIS TITLE IF THE CONTRACTOR OR GRANTEE:

1	(1) (I) COMPLIED WITH THE REQUIREMENTS OF § 20–104(C)
2	OF THIS TITLE; AND
3	(II) HAS COOPERATED WITH THE COMMISSIONER OR A
4	CONTRACTING AGENCY THAT IS INVESTIGATING AN ALLEGED VIOLATION OF §
5	20-104(C) OF THIS TITLE BY A SUBCONTRACTOR OR SUBGRANTEE;
6	(2) FOR A FIRST VIOLATION OF THIS TITLE BY THE CONTRACTOR
7	OR GRANTEE, ACTED IN GOOD FAITH; OR
8	(3) COMPLIED WITH THE REQUIREMENTS OF THIS TITLE
9	REGARDLESS OF ANY SUBSEQUENT DETERMINATION OF AN EMPLOYEE'S
10	ELIGIBILITY TO WORK.
