A BILL ENTITLED

1 AN ACT concerning

2 **Reduction of Lead Risk in Housing – Creation of Lead Poisoning**
3 **Compensation Fund**

4 FOR the purpose of establishing the Lead Poisoning Compensation Fund; establishing
5 the purposes of the Fund; establishing a Board of Trustees of the Fund;
6 providing for the membership of the Board; establishing the duties of the Board;
7 providing for the appointment of an Executive Director of the Fund;
8 establishing the powers and duties of the Executive Director; providing for the
9 appointment and removal of staff; requiring certain owners of residential rental
10 property to pay a Lead Poisoning Compensation Fee; establishing the amount of
11 and manner of collection of the fee; establishing that the Fund consists of
12 certain money; providing for the uses of the Fund; establishing that the Fund is
13 not a part of the State Treasury and that the debts and obligations of the Fund
14 are not a debt or pledge of credit of the State; providing for the management
15 and investment of the Fund; providing for auditing of the Fund; requiring the
16 Fund to provide coverage for certain claims to certain persons; authorizing
17 certain persons to obtain coverage from the Fund by paying a certain fee;
18 authorizing the Fund to provide coverage only if a claim is not covered by any
19 other source of insurance or indemnity; requiring the Executive Director to
20 settle, compromise, or defend claims against the Fund; authorizing the
21 Executive Director to authorize certain employees to record certain telephone
22 conversations under certain circumstances; providing for the establishment and
23 review of certain reserves; limiting the maximum amount payable by the Fund;
24 including employees and officials of the Fund in the definition of “State
25 personnel” for purposes of the Maryland Tort Claims Act; defining certain
26 terms; specifying the terms of the initial members of the Board of Trustees of
27 the Fund; and generally relating to reducing lead risk in housing and providing
28 compensation for injuries arising out of lead poisoning.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
26 MARYLAND, That the Laws of Maryland read as follows:

29 **SUBTITLE 1. DEFINITIONS.**

31 **(A) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
32 **INDICATED.**

33 **(B) “BOARD OF TRUSTEES” MEANS THE BOARD OF TRUSTEES OF THE**
34 **FUND.**

1 **(C) “COMPLIANT OWNER” MEANS AN OWNER OF RESIDENTIAL RENTAL**
2 **PROPERTY THAT, DURING THE PERIOD OF AN ALLEGED INGESTION OF LEAD ON**
3 **THE OWNER’S PROPERTY:**

4 **(1) HAD GIVEN TO THE TENANT THE NOTICES REQUIRED BY §§**
5 **6–820 AND 6–823 OF THE ENVIRONMENT ARTICLE; AND**

6 **(2) WAS IN COMPLIANCE WITH:**

7 **(I) THE REGISTRATION PROVISIONS OF TITLE 6, SUBTITLE**
8 **8, PART III OF THE ENVIRONMENT ARTICLE; AND**

9 **(II) THE APPLICABLE RISK REDUCTION STANDARD AND**
10 **RESPONSE STANDARD UNDER § 6–815 OR § 6–819 OF THE ENVIRONMENT**
11 **ARTICLE, AND THE RISK REDUCTION SCHEDULE UNDER § 6–817 OF THE**
12 **ENVIRONMENT ARTICLE.**

13 **(D) “EXECUTIVE DIRECTOR” MEANS THE EXECUTIVE DIRECTOR OF**
14 **THE FUND.**

15 **(E) “FUND” MEANS THE LEAD POISONING COMPENSATION FUND.**

16 **(F) (1) “OWNER” MEANS A PERSON, FIRM, CORPORATION, GUARDIAN,**
17 **CONSERVATOR, RECEIVER, TRUSTEE, EXECUTOR, OR LEGAL REPRESENTATIVE**
18 **THAT, ALONE OR JOINTLY OR SEVERALLY WITH OTHERS, OWNS, HOLDS, OR**
19 **CONTROLS THE WHOLE OR ANY PART OF THE FREEHOLD OR LEASEHOLD**
20 **INTEREST TO ANY PROPERTY, WITH OR WITHOUT ACTUAL POSSESSION.**

21 **(2) “OWNER” INCLUDES:**

22 **(I) ANY VENDEE IN POSSESSION OF THE PROPERTY; AND**

23 **(II) ANY AUTHORIZED AGENT OF THE OWNER, INCLUDING A**
24 **PROPERTY MANAGER OR LEASING AGENT.**

25 **(3) “OWNER” DOES NOT INCLUDE:**

26 **(I) A TRUSTEE OR A BENEFICIARY UNDER A DEED OF TRUST**
27 **OR A MORTGAGEE; OR**

28 **(II) THE OWNER OF A REVERSIONARY INTEREST UNDER A**
29 **GROUND LEASE.**

1 **SUBTITLE 2. ESTABLISHED; PURPOSE.**

2 **32-201.**

3 **THERE IS A LEAD POISONING COMPENSATION FUND.**

4 **32-202.**

5 **THE PURPOSE OF THE FUND IS TO PROVIDE:**

6 **(1) FOR THE PAYMENT OF COMPENSATION TO INDIVIDUALS THAT**
7 **SUFFER INJURIES ARISING OUT OF LEAD POISONING; AND**

8 **(2) A MEANS FOR OWNERS OF RESIDENTIAL RENTAL PROPERTY**
9 **TO OBTAIN COVERAGE FOR LIABILITY FOR INJURIES ARISING OUT OF LEAD**
10 **POISONING.**

11 **SUBTITLE 3. ADMINISTRATION OF FUND.**

12 **32-301.**

13 **(A) THERE IS A BOARD OF TRUSTEES OF THE FUND.**

14 **(B) (1) THE BOARD OF TRUSTEES CONSISTS OF SEVEN MEMBERS.**

15 **(2) OF THE SEVEN MEMBERS:**

16 **(I) SIX SHALL BE APPOINTED BY THE GOVERNOR WITH THE**
17 **ADVICE AND CONSENT OF THE SENATE; AND**

18 **(II) ONE SHALL BE THE EXECUTIVE DIRECTOR.**

19 **(3) EXCEPT AS PROVIDED IN § 32-302(A)(3) OF THIS SUBTITLE,**
20 **THE EXECUTIVE DIRECTOR MAY VOTE ON ALL MATTERS BEFORE THE BOARD**
21 **OF TRUSTEES.**

22 **(C) (1) A MEMBER APPOINTED BY THE GOVERNOR SERVES AT THE**
23 **PLEASURE OF THE GOVERNOR.**

24 **(2) THE TERM OF A MEMBER APPOINTED BY THE GOVERNOR IS 4**
25 **YEARS AND BEGINS ON JULY 1.**

1 **(3) THE TERMS OF MEMBERS APPOINTED BY THE GOVERNOR ARE**
2 **STAGGERED AS REQUIRED BY THE TERMS PROVIDED FOR MEMBERS OF THE**
3 **BOARD OF TRUSTEES ON JULY 1, 2012.**

4 **(4) AT THE END OF A TERM, A MEMBER APPOINTED BY THE**
5 **GOVERNOR CONTINUES TO SERVE UNTIL A SUCCESSOR IS CHOSEN AND**
6 **QUALIFIES.**

7 **(5) IF A MEMBER APPOINTED BY THE GOVERNOR CEASES TO BE A**
8 **MEMBER OF THE BOARD OF TRUSTEES, THE GOVERNOR SHALL APPOINT A**
9 **SUCCESSOR FOR THE UNEXPIRED TERM.**

10 **(D) (1) THE BOARD OF TRUSTEES SHALL CHOOSE A CHAIR FROM**
11 **AMONG ITS MEMBERS.**

12 **(2) THE EXECUTIVE DIRECTOR MAY NOT BE THE CHAIR OF THE**
13 **BOARD OF TRUSTEES.**

14 **(E) EACH MEMBER OF THE BOARD OF TRUSTEES IS ENTITLED TO:**

15 **(1) PER DIEM COMPENSATION SET BY THE BOARD OF PUBLIC**
16 **WORKS FOR EACH DAY ACTUALLY ENGAGED IN THE DISCHARGE OF OFFICIAL**
17 **DUTIES, IF THE MEMBER IS NOT OTHERWISE AN OFFICER OR EMPLOYEE OF THE**
18 **STATE; AND**

19 **(2) REIMBURSEMENT FOR EXPENSES UNDER THE STANDARD**
20 **STATE TRAVEL REGULATIONS, AS PROVIDED IN THE BUDGET OF THE BOARD OF**
21 **TRUSTEES.**

22 **(F) THE BOARD OF TRUSTEES SHALL FORMULATE POLICY FOR THE**
23 **FUND.**

24 **32-302.**

25 **(A) (1) THE BOARD OF TRUSTEES SHALL APPOINT THE EXECUTIVE**
26 **DIRECTOR OF THE FUND WITH THE APPROVAL OF THE GOVERNOR.**

27 **(2) THE EXECUTIVE DIRECTOR SERVES AT THE PLEASURE OF**
28 **THE BOARD OF TRUSTEES.**

29 **(3) THE INCUMBENT EXECUTIVE DIRECTOR MAY NOT VOTE ON**
30 **THE CHOICE OF A SUCCESSOR.**

1 **(4) IF THE BOARD OF TRUSTEES FAILS TO AGREE ON A**
2 **SUCCESSOR, THE GOVERNOR SHALL APPOINT THE SUCCESSOR.**

3 **(B) (1) THE EXECUTIVE DIRECTOR:**

4 **(I) IS THE ADMINISTRATIVE HEAD OF THE FUND; AND**

5 **(II) SHALL EXERCISE THE POWERS AND PERFORM THE**
6 **DUTIES CONFERRED ON THE FUND BY THIS TITLE, EXCEPT FOR THOSE POWERS**
7 **AND DUTIES CONFERRED ON THE BOARD OF TRUSTEES.**

8 **(2) THE BOARD OF TRUSTEES SHALL ADVISE THE EXECUTIVE**
9 **DIRECTOR ON THE EXERCISE OF THE POWERS AND DUTIES CONFERRED ON THE**
10 **EXECUTIVE DIRECTOR BY THIS TITLE.**

11 **(C) THE BOARD OF TRUSTEES SHALL DETERMINE THE COMPENSATION**
12 **OF THE EXECUTIVE DIRECTOR WITH THE APPROVAL OF THE GOVERNOR.**

13 **32-303.**

14 **(A) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
15 **SUBSECTION OR OTHERWISE BY LAW, THE EXECUTIVE DIRECTOR SHALL**
16 **APPOINT AND REMOVE STAFF OF THE FUND IN ACCORDANCE WITH THE**
17 **PROVISIONS OF THE STATE PERSONNEL AND PENSIONS ARTICLE.**

18 **(2) POSITIONS THAT THE EXECUTIVE DIRECTOR DESIGNATES**
19 **WITH THE APPROVAL OF THE BOARD OF TRUSTEES AS TECHNICAL OR**
20 **PROFESSIONAL POSITIONS ARE IN THE EXECUTIVE SERVICE, MANAGEMENT**
21 **SERVICE, OR ARE SPECIAL APPOINTMENTS OF THE SKILLED SERVICE OR THE**
22 **PROFESSIONAL SERVICE IN THE STATE PERSONNEL MANAGEMENT SYSTEM.**

23 **(3) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE**
24 **EXECUTIVE DIRECTOR MAY APPOINT CLAIMS ADJUSTERS, ATTORNEYS, AND**
25 **OTHER NECESSARY PERSONS DIRECTLY AS EMPLOYEES OR ON A CONTRACT**
26 **BASIS.**

27 **(B) THE EXECUTIVE DIRECTOR SHALL DETERMINE AND ADMINISTER**
28 **THE COMPENSATION OF THE PERSONNEL OF THE FUND DESIGNATED UNDER**
29 **SUBSECTION (A)(2) OF THIS SECTION WITH THE APPROVAL OF THE BOARD OF**
30 **TRUSTEES.**

31 **(C) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE, AN**
32 **EMPLOYEE OF THE FUND IS NOT SUBJECT TO ANY LAW, REGULATION, OR**

1 EXECUTIVE ORDER GOVERNING STATE EMPLOYEE COMPENSATION, INCLUDING
2 FURLOUGHS, SALARY REDUCTIONS, AND ANY OTHER GENERAL FUND
3 COST-SAVING MEASURE.

4 SUBTITLE 4. FEES; MANAGEMENT OF FUND.

5 32-401.

6 (A) ON OR AFTER JULY 1, 2013, A LEAD POISONING COMPENSATION
7 FEE SHALL BE PAID BY EACH OWNER OF RESIDENTIAL RENTAL PROPERTY
8 LOCATED IN THE STATE THAT WAS BUILT BEFORE 1978.

9 (B) THE LEAD POISONING COMPENSATION FEE IS:

10 (1) FOR AN OWNER THAT IS NOT A COMPLIANT OWNER, \$500 PER
11 RENTAL DWELLING UNIT;

12 (2) FOR A COMPLIANT OWNER:

13 (I) \$100 PER RENTAL DWELLING UNIT; OR

14 (II) \$50 PER RENTAL DWELLING UNIT CERTIFIED AS
15 LIMITED LEAD-FREE IN ACCORDANCE WITH REGULATIONS ADOPTED BY THE
16 DEPARTMENT OF THE ENVIRONMENT.

17 (3) AN OWNER IS EXEMPT FROM PAYING THE FEE IF THE
18 OWNER'S PROPERTY IS CERTIFIED AS LEAD-FREE IN ACCORDANCE WITH
19 REGULATIONS ADOPTED BY THE DEPARTMENT OF THE ENVIRONMENT.

20 (C) (1) THE COUNTY IN WHICH THE PROPERTY IS LOCATED SHALL
21 COLLECT THE FEE BY INCLUDING THE FEE ON AN OWNER'S ANNUAL OR
22 SEMIANNUAL PROPERTY TAX BILL.

23 (2) THE STATE DEPARTMENT OF ASSESSMENTS AND TAXATION
24 AND THE DEPARTMENT OF THE ENVIRONMENT SHALL COOPERATE WITH EACH
25 COUNTY TO IDENTIFY THE PROPERTY OWNERS THAT ARE LIABLE FOR PAYMENT
26 OF THE FEE UNDER THIS SECTION AND THE AMOUNT OF THE FEE DUE FOR EACH
27 DWELLING UNIT.

28 (3) A COUNTY:

1 **(I) MAY USE ALL OF ITS EXISTING PROCEDURES AND**
2 **AUTHORITY FOR COLLECTING PROPERTY TAXES IN ORDER TO ENFORCE THE**
3 **COLLECTION OF THE FEE; AND**

4 **(II) SHALL ESTABLISH A SEGREGATED ACCOUNT FOR THE**
5 **DEPOSIT OF FUNDS COLLECTED UNDER THIS SECTION.**

6 **(D) (1) A COUNTY SHALL COMPLETE AND SUBMIT UNDER OATH A**
7 **RETURN AND REMIT THE FEES COLLECTED UNDER THIS SECTION TO THE**
8 **COMPTROLLER ON OR BEFORE THE DATES SPECIFIED BY THE COMPTROLLER**
9 **BY REGULATION.**

10 **(2) EXCEPT TO THE EXTENT OF ANY INCONSISTENCY WITH THIS**
11 **SECTION, THE PROVISIONS OF TITLE 13 OF THE TAX – GENERAL ARTICLE THAT**
12 **ARE APPLICABLE TO THE SALES AND USE TAX SHALL GOVERN THE**
13 **ADMINISTRATION, COLLECTION, AND ENFORCEMENT OF THE FEE UNDER THIS**
14 **SECTION.**

15 **(3) THE COMPTROLLER MAY ADOPT REGULATIONS NECESSARY**
16 **TO ADMINISTER, COLLECT, AND ENFORCE THE FEE.**

17 **(4) THE STATE CENTRAL COLLECTION UNIT MAY COLLECT**
18 **DELINQUENT ACCOUNTS UNDER THIS SECTION IN ACCORDANCE WITH § 3-302**
19 **OF THE STATE FINANCE AND PROCUREMENT ARTICLE.**

20 **32-402.**

21 **(A) THE FUND CONSISTS OF:**

22 **(1) FEES COLLECTED UNDER § 32-401 OF THIS SUBTITLE AND §**
23 **32-501(B) OF THIS TITLE;**

24 **(2) INTEREST OR OTHER INCOME EARNED ON THE INVESTMENT**
25 **OF MONEY IN THE FUND; AND**

26 **(3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR**
27 **THE BENEFIT OF THE FUND.**

28 **(B) (1) ALL OPERATING EXPENSES OF THE FUND SHALL BE PAID**
29 **FROM THE MONEY COLLECTED BY OR FOR THE FUND.**

1 **(2) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH,**
2 **MONEY AND PROPERTY AVAILABLE TO THE FUND MAY BE USED FOR THE**
3 **GENERAL PURPOSES OF THE FUND.**

4 **(II) FEES COLLECTED AND INCOME ACCRUING FROM THOSE**
5 **FEES MAY BE USED ONLY FOR THE PAYMENT OF CLAIMS AND FOR THE**
6 **ADMINISTRATIVE EXPENSES OF THE FUND.**

7 **32-403.**

8 **(A) THE ACCOUNT OF THE FUND IS A SPECIAL FUND ACCOUNT AND IS**
9 **NOT A PART OF THE STATE TREASURY.**

10 **(B) THE DEBTS AND OBLIGATIONS OF THE FUND ARE NOT A DEBT OF**
11 **THE STATE OR A PLEDGE OF THE CREDIT OF THE STATE.**

12 **32-404.**

13 **(A) (1) A FINANCIAL MANAGEMENT COMMITTEE OF THE FUND SHALL**
14 **MANAGE AND INVEST ALL MONEY COLLECTED BY OR FOR THE FUND THROUGH**
15 **FEES, APPROPRIATIONS, EARNINGS FROM INVESTMENTS, OR FROM OTHER**
16 **SOURCES.**

17 **(2) THE FINANCIAL MANAGEMENT COMMITTEE CONSISTS OF THE**
18 **EXECUTIVE DIRECTOR AND TWO MEMBERS OF THE BOARD OF TRUSTEES WHOM**
19 **THE BOARD OF TRUSTEES CHOOSES.**

20 **(B) (1) WHENEVER THE AMOUNT OF MONEY IN THE FUND EXCEEDS**
21 **THE AMOUNT THAT THE EXECUTIVE DIRECTOR BELIEVES IS LIKELY TO BE**
22 **REQUIRED IMMEDIATELY, THE FINANCIAL MANAGEMENT COMMITTEE MAY**
23 **MANAGE THE EXCESS AS THE COMMITTEE CONSIDERS APPROPRIATE AND**
24 **INVEST THE EXCESS IN INVESTMENTS AUTHORIZED UNDER TITLE 5, SUBTITLE 6**
25 **OF THIS ARTICLE.**

26 **(2) IF USE OF THE EXCESS BECOMES NECESSARY OR EXPEDIENT,**
27 **THE FINANCIAL MANAGEMENT COMMITTEE MAY COLLECT, SELL, OR**
28 **OTHERWISE REALIZE ON THE INVESTMENT AND ANY ACCRUED INTEREST.**

29 **(C) (1) (I) CONSISTENT WITH MINORITY BUSINESS PURCHASING**
30 **STANDARDS APPLICABLE TO UNITS OF STATE GOVERNMENT UNDER THE STATE**
31 **FINANCE AND PROCUREMENT ARTICLE AND CONSISTENT WITH THE FIDUCIARY**
32 **DUTIES OF THE FINANCIAL MANAGEMENT COMMITTEE, THE FINANCIAL**
33 **MANAGEMENT COMMITTEE SHALL ATTEMPT TO USE TO THE GREATEST EXTENT**

1 FEASIBLE MINORITY BUSINESS ENTERPRISES TO PROVIDE BROKERAGE AND
2 INVESTMENT MANAGEMENT SERVICES TO THE COMMITTEE.

3 (II) FOR PURPOSES OF THIS SUBSECTION, BROKERAGE AND
4 INVESTMENT MANAGEMENT SERVICES SHALL INCLUDE SERVICES RELATING TO
5 ALL ALLOCATED ASSET CLASSES.

6 (2) (I) TO ASSIST THE FINANCIAL MANAGEMENT COMMITTEE
7 IN ACHIEVING THE GOAL DESCRIBED UNDER PARAGRAPH (1) OF THIS
8 SUBSECTION, THE COMMITTEE SHALL UNDERTAKE MEASURES TO REMOVE ANY
9 BARRIERS THAT LIMIT FULL PARTICIPATION BY MINORITY BUSINESS
10 ENTERPRISES IN BROKERAGE AND INVESTMENT MANAGEMENT SERVICES
11 OPPORTUNITIES AFFORDED BY THE FUND.

12 (II) THE MEASURES UNDERTAKEN BY THE FINANCIAL
13 MANAGEMENT COMMITTEE SHALL INCLUDE THE USE OF A WIDE VARIETY OF
14 MEDIA, INCLUDING THE FUND'S WEB SITE, TO PROVIDE NOTICE TO A BROAD
15 AND VARIED RANGE OF POTENTIAL PROVIDERS ABOUT THE BROKERAGE AND
16 INVESTMENT MANAGEMENT SERVICES OPPORTUNITIES AFFORDED BY THE
17 FUND.

18 (3) IN CONJUNCTION WITH THE GOVERNOR'S OFFICE OF
19 MINORITY AFFAIRS, THE FINANCIAL MANAGEMENT COMMITTEE SHALL
20 DEVELOP GUIDELINES TO ASSIST THE COMMITTEE IN IDENTIFYING AND
21 EVALUATING QUALIFIED MINORITY BUSINESS ENTERPRISES IN ORDER TO HELP
22 THE FUND ACHIEVE THE OBJECTIVE FOR GREATER USE OF MINORITY BUSINESS
23 ENTERPRISES FOR BROKERAGE AND INVESTMENT MANAGEMENT SERVICES.

24 (4) ON OR BEFORE SEPTEMBER 1 OF EACH YEAR, THE FINANCIAL
25 MANAGEMENT COMMITTEE SHALL SUBMIT A REPORT TO THE GOVERNOR'S
26 OFFICE OF MINORITY AFFAIRS AND, SUBJECT TO § 2-1246 OF THE STATE
27 GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY ON:

28 (I) THE IDENTITY OF THE MINORITY BUSINESS
29 ENTERPRISE BROKERAGE AND INVESTMENT MANAGEMENT SERVICES FIRMS
30 USED BY THE FINANCIAL MANAGEMENT COMMITTEE IN THE IMMEDIATELY
31 PRECEDING FISCAL YEAR;

32 (II) THE PERCENTAGE AND DOLLAR VALUE OF THE FUND
33 ASSETS THAT ARE UNDER THE INVESTMENT CONTROL OF MINORITY BUSINESS
