## A BILL ENTITLED

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That the Laws of Maryland read as follows:

- 18 (1) intentionally mutilate, torture, cruelly beat, or cruelly kill an 19 animal;
- 20 (2) cause, procure, or authorize an act prohibited under item (1) of this 21 subsection; or
- (3) except in the case of self-defense, intentionally inflict bodily harm,
   permanent disability, or death on an animal owned or used by a law enforcement unit.
