1 AN ACT concerning

2 **Frederick County – Tax Sales – Auctioneer’s Fees**

3 FOR the purpose of setting the amount of the auctioneer’s fee allowed in Frederick
4 County relating to certain tax sales to be the lowest responsive bid for each
5 property sold; and generally relating to tax sales in Frederick County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article – Tax – Property**

19 14–813.

1 (e) (1) The following expenses relating to the sale shall be allowed, all of
2 which are liens on the property to be sold:

3 (iv) the auctioneer's fee, as provided in paragraph (2) of this
4 subsection;

5 (2) The auctioneer's fee allowed in paragraph (1) of this subsection
6 shall be:

7 (i) except in Baltimore City, Caroline County, Carroll County,
8 Cecil County, Dorchester County, **FREDERICK COUNTY**, Garrett County, Howard
9 County, Kent County, Prince George's County, Queen Anne's County, Somerset
10 County, Talbot County, Wicomico County, or Worcester County:

11 1. for any date when 1, 2, or 3 properties are sold, an
12 amount not to exceed \$10; and

13 2. for any date when 4 or more properties are sold, \$3 for
14 each property sold;

15 (ii) in Dorchester County, \$7.50 for each property sold;

16 (iii) in Kent County, an amount not exceeding \$7.50 for each
17 property sold;

18 (iv) in Cecil County and Queen Anne's County, \$7.50 for each
19 property sold;

20 (v) in Garrett County, Somerset County, and Wicomico County,
21 \$8 for each property sold;

22 (vi) in Worcester County, the greater of \$8 for each property sold
23 or \$300, to be allocated pro rata among each property sold;

24 (vii) in Baltimore City:

25 1. for any date when 1, 2, or 3 properties are sold, an
26 amount not to exceed \$10;

27 2. for any date when 4 or more properties are sold, \$3 for
28 each property sold; and

29 3. in an electronic sale, an amount not to exceed \$10 for
30 each property sold;

31 (viii) in Carroll County, the amount set by the Carroll County
32 Commissioners; [and]

1 (ix) in Caroline County, Howard County, Prince George's
2 County, and Talbot County, \$10 for each property sold; AND

3 (X) IN FREDERICK COUNTY, THE LOWEST RESPONSIVE BID
4 FOR EACH PROPERTY SOLD.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
6 July 1, 2012.
