A BILL ENTITLED

1 AN ACT concerning

2 **Horse Racing – Maryland Standardbred Race Fund Advisory Committee –**
3 **Registration of Horses**

4 FOR the purpose of altering a method by which a horse may be registered with the
5 Maryland Standardbred Race Fund Advisory Committee to enable the horse to
6 start in a race of the Foaled Stakes Program; and generally relating to horse
7 racing and the Maryland Standardbred Race Fund Advisory Committee.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Business Regulation**

21 11–623.

22 (a) In this part the following words have the meanings indicated.

1 (b) "Advisory Committee" means the Maryland Standardbred Race Fund
2 Advisory Committee.

3 11-632.

4 (a) A horse shall be registered with the Advisory Committee before the horse
5 may start in a race of the Foaled Stakes Program.

6 (b) A horse may be registered with the Advisory Committee only if the horse
7 was foaled in Maryland as shown by a foal certificate from the United States Trotting
8 Association and:

9 (1) the breeder of the horse has maintained a place of abode in
10 Maryland for more than 9 months immediately before registration;

11 (2) the breeder of the horse keeps breeding stock continually in
12 Maryland;

13 (3) the horse was conceived [in Maryland] during the previous season
14 **BY THE HORSE'S DAM BEING COVERED BY A MARYLAND STALLION REGISTERED**
15 **WITH THE ADVISORY COMMITTEE; or**

16 (4) the horse's dam was sent to Maryland to foal and after foaling was
17 covered by a Maryland stallion during the season of the horse's birth.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2012.
