Loan Assistance Repayment Program - Nancy Grasmick Teacher Scholars

- FOR the purpose of establishing the Nancy Grasmick Teacher Grant in the Janet L. 3 4 Hoffman Loan Assistance Repayment Program; requiring the Office of Student 5 Financial Assistance to assist in the repayment of certain higher education 6 loans owed by certain individuals who receive certain degrees from certain 7 institutions of higher education in the State or out of the State; requiring the 8 Office to assist in the repayment of the amount of any higher education loan 9 owed by certain public school teachers in the State who teach certain subjects or 10 teach in certain schools for a certain amount of time; providing that a recipient of a Nancy Grasmick Teacher Grant shall be known as a Nancy Grasmick 11 12 Teacher Scholar; requiring that certain regulations establishing priority for participation in the Janet L. Hoffman Loan Assistance Repayment Program 13 include an individual who qualifies for a Nancy Grasmick Teacher Grant and 14 15 meets other specified qualifications; and generally relating to the creation of the 16 Nancy Grasmick Teacher Grant in the Loan Assistance Repayment Program.

- [(c)] (E) An applicant for assistance in the repayment of a commercial loan shall demonstrate to the Office that the commercial loan was used for tuition, educational expenses, or living expenses for graduate or undergraduate study.
