Loan Assistance Repayment Program - Nancy Grasmick Teacher Scholars

- 3 FOR the purpose of establishing the Nancy Grasmick Teacher Grant Award in the 4 Janet L. Hoffman Loan Assistance Repayment Program; requiring the Office of 5 Student Financial Assistance to assist in the repayment of certain higher 6 education loans owed by certain individuals who receive certain degrees from 7 certain institutions of higher education in the State or out of the State; 8 requiring the Office to assist in the repayment of the amount of any higher 9 education loan owed by certain public school teachers in the State who teach 10 certain subjects or teach in certain schools in Maryland for a certain amount of 11 time; providing that a recipient of a Nancy Grasmick Teacher Grant Award 12 shall be known as a Nancy Grasmick Teacher Scholar; requiring that certain 13 regulations establishing priority for participation in the Janet L. Hoffman Loan Assistance Repayment Program include, for teacher applicants only, an 14 individual who qualifies for a Nancy Grasmick Teacher Grant Award and meets 15 other specified qualifications; prohibiting the Office from approving more than a 16 17 certain percentage of awards for teacher applicants to Nancy Grasmick Teacher 18 Scholars; and generally relating to the creation of the Nancy Grasmick Teacher 19 Grant Award in the Loan Assistance Repayment Program.

- I [(c)] (E) An applicant for assistance in the repayment of a commercial loan shall demonstrate to the Office that the commercial loan was used for tuition, educational expenses, or living expenses for graduate or undergraduate study.
- 4 **[(d)] (F)** Assistance in the repayment of a loan from an entity set forth in § 5 18–1501(c)(2) of this subtitle shall require the approval of the Office.

- 7 (a) The Office of Student Financial Assistance shall adopt regulations to 8 establish:
- 9 (1) The maximum starting income for eligibility in the Janet L. 10 Hoffman Loan Assistance Repayment Program;
- 11 (2) The maximum total income for eligibility in the Janet L. Hoffman 12 Loan Assistance Repayment Program, including any additional sources of income;
- 13 (3) That priority for participation in the Program shall be given to an 14 individual who:
- 15 (i) Graduated from an institution of higher education in the 16 last 3 years;
- 17 (ii) Is a resident of the State;
- 18 (iii) Is employed on a full–time basis; and
- 19 (iv) **1.** Provides, as the principal part of the individual's employment, legal services to low-income residents in the State who cannot afford legal services, nursing services in nursing shortage areas in the State as defined in § 18–802 of this title, or other services in an eligible field of employment in which there is a shortage of qualified practitioners to low-income or underserved residents or areas of the State; **OR**

2. Qualifies For teacher applicants only, Qualifies for a Nancy Grasmick Teacher Grant Award;

- 27 (4) A limit on the total amount of assistance provided by the Office of Student Financial Assistance in repaying the loan of an eligible individual, based on the individual's total income and outstanding higher education loan balance;
- 30 (5) A procedure and schedule for the payment of the amount of loan 31 assistance provided by the Office of Student Financial Assistance to the eligible 32 individual; and

- 1 (6) An annual review of the eligibility of each individual participating 2 in the Program.

- 9 (a) Funds for the Janet L. Hoffman Loan Assistance Repayment Program described in subsection (b)(2) of this section shall be allocated by the Commission to an individual who:
- 12 (1) Has received a graduate degree from a school of law; and
- 13 (2) Has submitted an application for the Janet L. Hoffman Loan 14 Assistance Repayment Program that the Commission disapproved due to insufficient 15 funds.

- Subject to § 2–1246 of the State Government Article, the Office of Student Financial Assistance shall report to the General Assembly by January 1 of each year on the implementation of the Janet L. Hoffman Loan Assistance Repayment Program.
