- 2 Vehicle Laws Historic Motor Vehicles Trucks, Tractors, and Motor Homes
- 3 FOR the purpose of establishing a certain historic motor vehicle registration for 4 certain trucks, tractors, and motor homes; establishing certain qualifications for 5 a historic motor vehicle registration under this Act; establishing certain 6 registration fees; prohibiting a vehicle registered under this Act from being used 7 in a certain manner; requiring a certain owner applying for registration of a 8 vehicle under this Act to certify that the vehicle will be maintained only for 9 certain purposes; requiring the Motor Vehicle Administration to issue certain 10 registration plates under certain circumstances; providing that the presence of certain equipment is not required for the operation of a vehicle registered under 11 12 this Act; exempting a vehicle registered under this Act from certain vehicle 13 inspections; clarifying that this Act does not limit the authority of a police officer to issue a certain safety equipment repair order; prohibiting the transfer 14 15 to a subsequent owner of a registration issued under this Act; defining a certain 16 term; and generally relating to the registration of historic motor vehicles.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 5 (A) IN THIS SECTION, "HISTORIC MOTOR VEHICLE" MEANS A CLASS E
- 6 (TRUCK) WITH A MANUFACTURER'S GROSS VEHICLE WEIGHT RATING IN EXCESS
- 7 OF 10,000 POUNDS, CLASS F (TRACTOR), OR A CLASS M (MULTIPURPOSE)
- 8 MOTOR HOME THAT:
- 9 (1) IS AT LEAST 25 YEARS OLD;
- 10 (2) HAS NOT BEEN SUBSTANTIALLY ALTERED FROM THE
- 11 MANUFACTURER'S ORIGINAL DESIGN; AND
- 12 (3) MEETS CRITERIA CONTAINED IN REGULATIONS ADOPTED BY
- 13 THE ADMINISTRATION.
- 14 (B) IN THIS SECTION, "HISTORIC MOTOR VEHICLE" DOES NOT INCLUDE
- 15 A VEHICLE THAT HAS BEEN REMANUFACTURED OR RECONSTRUCTED AS A
- 16 REPLICA OF AN ORIGINAL VEHICLE.
- 17 (C) IF REGISTERED WITH THE ADMINISTRATION UNDER THIS SECTION,
- 18 EVERY HISTORIC MOTOR VEHICLE IS A CLASS L (HISTORIC) VEHICLE.
- 19 (D) EXCEPT AS PROVIDED IN SUBSECTION (I) OF THIS SECTION, FOR
- 20 EACH CLASS L (HISTORIC) VEHICLE, THE ANNUAL REGISTRATION FEE IS
- 21 **\$25.50**.
- 22 (E) (1) A HISTORIC MOTOR VEHICLE REGISTERED UNDER THIS
- 23 SECTION MAY NOT BE USED FOR:
- 24 (I) GENERAL DAILY TRANSPORTATION; OR
- 25 (II) ANY COMMERCIAL TRANSPORTATION OF PASSENGERS
- 26 OR PROPERTY ON HIGHWAYS.
- 27 (2) IN APPLYING FOR REGISTRATION OF A HISTORIC MOTOR
- 28 VEHICLE UNDER THIS SECTION, THE OWNER OF THE VEHICLE SHALL SUBMIT
- 29 WITH THE APPLICATION A CERTIFICATION THAT THE VEHICLE FOR WHICH THE
- 30 APPLICATION IS MADE:

5 6	2. ANY COMMERCIAL TRANSPORTATION OF PASSENGERS OR PROPERTY ON HIGHWAYS; AND
7 8	(III) IS INSURED BY A HISTORIC VEHICLE, A SHOW VEHICLE, OR AN ANTIQUE VEHICLE INSURANCE POLICY.
9	(F) EXCEPT AS PROVIDED IN § 13–936.1 OF THIS SUBTITLE, ON
10	REGISTRATION OF A VEHICLE UNDER THE SECTION, THE ADMINISTRATION
11	SHALL ISSUE A SPECIAL, HISTORIC MOTOR VEHICLE REGISTRATION PLATE OF
12	THE SIZE AND DESIGN THAT THE ADMINISTRATION DETERMINES.
13	(G) UNLESS THE PRESENCE OF THE EQUIPMENT WAS SPECIFICALLY
14	REQUIRED BY A STATUTE OF THIS STATE AS A CONDITION OF SALE WHEN THE
15	VEHICLE WAS MANUFACTURED, THE PRESENCE OF ANY SPECIFIC EQUIPMENT IS
16	NOT REQUIRED FOR THE OPERATION OF A VEHICLE REGISTERED UNDER THIS
17	SECTION.
18	(H) (1) A VEHICLE REGISTERED UNDER THIS SECTION IS EXEMPT
19	FROM ANY STATUTE THAT REQUIRES PERIODIC VEHICLE INSPECTIONS OR THAT
20	REQUIRES THE USE AND INSPECTION OF EMISSION CONTROLS.
21	(2) PARAGRAPH (1) OF THIS SUBSECTION MAY NOT BE
22	CONSTRUED TO LIMIT THE AUTHORITY OF A POLICE OFFICER TO ISSUE A
23	SAFETY EQUIPMENT REPAIR ORDER FOR DEFECTIVE EQUIPMENT UNDER §
24	23–105 OF THIS ARTICLE.
25	(I) (1) FOR A MOTOR VEHICLE MANUFACTURED AT LEAST 60 YEARS
26	PRIOR TO THE CURRENT MODEL YEAR, THERE IS A ONETIME REGISTRATION FEE
27	OF \$50.00.
28	(2) REGISTRATION OF A MOTOR VEHICLE DESCRIBED IN
29	PARAGRAPH (1) OF THIS SUBSECTION IS NOT TRANSFERABLE TO A SUBSEQUENT
30	OWNER.
31	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
