2 Montgomery County – Solicitation of Money or Donations from Occupants of 3 Vehicles – Adoption of a Permit Program or Prohibition

5 FOR the purpose of authorizing the Montgomery County Council to enact a local law 6 to require a person to obtain a certain permit before standing in a median 7 divider or on a sidewalk adjacent to a roadway to solicit money or donations of 8 any kind from the occupant of a vehicle; prohibiting a person from standing in a 9 roadway, median divider, or intersection, or on a sidewalk adjacent to a 10 roadway, to solicit money or donations from the occupant of a vehicle, if a 11 certain permit is required under a local law enacted under this Act and the permit has not been obtained in accordance with the local law; prohibiting a 12 local law enacted under this Act from authorizing a permit to be issued to a 13 minor for certain purposes; authorizing the Montgomery County Council to 14 15 enact a local law to prohibit a person from standing in a roadway, median 16 divider, or intersection to solicit money or donations of any kind from the 17 occupant of a vehicle; and generally relating to the solicitation of money or 18 donations from occupants of vehicles in Montgomery County.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

**Article - Transportation**

- [(1)] (2) (I) [In Montgomery County, a] A child under the age of the second to solicit money or donations of any kind from the occupant of a vehicle.
- [(2)] (II) This [subsection] PARAGRAPH shall be enforced by the issuance of a warning that informs the offender of the requirements of this [subsection] PARAGRAPH.
- 9 (3) (I) THE MONTGOMERY COUNTY COUNCIL MAY ENACT A
  10 LOCAL LAW TO REQUIRE A PERSON TO OBTAIN A PERMIT BEFORE THE PERSON

  ADJACENT TO A ROADWAY, TO SOLICIT MONEY OR DONATIONS OF ANY KIND
  FROM THE OCCUPANT OF A VEHICLE.

  21 AUTHORIZE A PERMIT TO BE ISSUED TO A MINOR FOR THE PURPOSE OF

  23 TO SOLICIT MONEY OR DONATIONS OF ANY KIND FROM THE OCCUPANT OF A
  24 VEHICLE.
- 25 (4) THE MONTGOMERY COUNTY COUNCIL MAY ENACT A LOCAL
  26 LAW TO PROHIBIT A PERSON FROM STANDING IN A ROADWAY, MEDIAN DIVIDER,
  27 OR INTERSECTION TO SOLICIT MONEY OR DONATIONS OF ANY KIND FROM THE
  28 OCCUPANT OF A VEHICLE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2012.
