CHAPTER _____

1 AN ACT concerning

State Retirement and Pension System – Transfer of Members Between Systems

4 FOR the purpose of providing that if an individual who was a member of one of the 5 several systems in the State Retirement and Pension System on a certain date 6 becomes a member of another one of the several systems on or after a certain 7 date, the individual shall be considered to be a new member of the subsequent 8 system as of a certain date, but is subject to certain requirements that were in 9 place for the subsequent system on a certain date; and is subject to the same 10 requirements to which an individual who was a member of the subsequent system on a certain date and remains a member on a certain date is subject; 11 12 providing for the application of this Act; and generally relating to the transfer of members between the State retirement and pension systems on or after a 13 14 certain date.
