A BILL ENTITLED

1 AN ACT concerning

2 **Education – Prince George's County School Board Budgets – Transparency**

3 **PG 410–12**

4 FOR the purpose of requiring a certain Web site of the Prince George's County Board
5 of Education to include certain budget data; requiring the Web site to contain
6 annual data and to be searchable based on individual schools; and generally
7 relating to a searchable Web site of the Prince George's County Board of
8 Education.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Education**

17 5–118.

18 (a) (1) In this section the following words have the meanings indicated.

19 (2) (i) “Payee” means any party who receives from the Prince
20 George's County Board of Education an aggregate payment of \$25,000 in a fiscal year.

21 (ii) “Payee” does not include:

1 1. A Prince George's County public school employee with
2 respect to the employee's compensation; or

3 2. A Prince George's County public school retiree with
4 respect to the retiree's retirement allowance.

5 (3) "Searchable Web site" means a Web site created in accordance with
6 this section that displays and searches payment **AND BUDGET** data of the Prince
7 George's County Board of Education.

8 (b) On or before January 1, 2013, the Prince George's County Board of
9 Education shall develop and operate a single searchable Web site accessible to the
10 public at no cost through the Internet.

11 (c) The searchable Web site shall contain Prince George's County Board of
12 Education [payment] **ANNUAL** data including:

13 (1) The name of a payee receiving a payment;

14 (2) The location of a payee by zip code; [and]

15 (3) The amount of a payment; **AND**

16 (4) **THE BUDGET DATA PREPARED UNDER § 5-101 OF THIS**
17 **SUBTITLE.**

18 (d) The searchable Web site shall allow the user to:

19 (1) Search data for fiscal year 2012 and each fiscal year thereafter;
20 and

21 (2) Search by the following data fields:

22 (i) A payee receiving a payment; [and]

23 (ii) The zip code of a payee receiving a payment; **AND**

24 **(III) INDIVIDUAL SCHOOLS.**

25 (e) This section may not be construed to require the disclosure of information
26 that is confidential under federal, State, or local law.

27 (f) This section shall be known and may be cited as the "Prince George's
28 County Public Schools Funding Accountability and Transparency Act".

1 SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding any
2 other provision of law, budget data beginning with fiscal year 2013 and each fiscal
3 year thereafter shall be included on the searchable Web site established under § 5–118
4 of the Education Article.

5 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
6 July 1, 2012.
