1 AN ACT concerning

2 **Respiratory Care Practitioners – Practicing Polysomnography – Licensing**
3 **Exceptions**

4 FOR the purpose of providing that a licensed respiratory care practitioner has the
5 right to practice respiratory care within the scope of practice of the respiratory
6 care practitioner’s license, including practicing respiratory care in a sleep
7 laboratory; providing that the licensing requirements to practice
8 polysomnography do not apply to a certain respiratory care practitioner licensed
9 by the State Board of Physicians on or before a certain date; and generally
10 relating to licensing exceptions to the practice of polysomnography by
11 respiratory care practitioners.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article – Health Occupations**

20 14–5C–02.

1 This subtitle does not limit:

2 (1) The right of an individual to practice a health occupation that the
3 individual is authorized to practice under this article; [or]

4 (2) The right of a licensed home medical equipment provider to
5 provide home medical equipment services as defined under Title 19, Subtitle 4A of the
6 Health – General Article; **OR**

7 **(3) THE RIGHT OF A LICENSED RESPIRATORY CARE**
8 **PRACTITIONER TO PRACTICE RESPIRATORY CARE WITHIN THE SCOPE OF**
9 **PRACTICE OF THE RESPIRATORY CARE PRACTITIONER’S LICENSE, INCLUDING**
10 **PRACTICING RESPIRATORY CARE IN A SLEEP LABORATORY.**

11 14–5C–08.

12 (a) Except as otherwise provided in this subtitle, on or after October 1, 2013,
13 an individual shall be licensed by the Board before the individual may practice
14 polysomnography in this State.

15 (b) This section does not apply to a student enrolled in an education program
16 under § 14–5C–09(c)(3) of this subtitle while practicing polysomnography in that
17 program.

18 **(c) THIS SECTION DOES NOT APPLY TO A RESPIRATORY CARE**
19 **PRACTITIONER WHO WAS LICENSED BY THE BOARD TO PRACTICE RESPIRATORY**
20 **CARE ON OR BEFORE DECEMBER 31, 2012, AND WHOSE DUTIES INCLUDE**
21 **PRACTICING POLYSOMNOGRAPHY.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2012.
