# Vehicle Laws - Red Light and Speed Monitoring Systems - Law Enforcement Vehicles

FOR the purpose of providing that certain images of a law enforcement vehicle
recorded by a traffic control signal monitoring system, a speed monitoring
system, or a work zone speed control system may not be the basis for a civil
penalty or the issuance of a citation under certain provisions of law; and
generally relating to traffic control signal monitoring systems, speed monitoring
systems, and work zone speed control systems.
