5 FOR the purpose of ~~altering the terms of Washington Suburban Sanitary District~~  
6 ~~bonds and refunding bonds that may be issued by the Washington Suburban~~  
7 ~~Sanitary Commission to decrease the number of years that a bond may mature~~  
8 ~~from the date of issuance; requiring the Commission to reduce a certain sum~~  
9 ~~owed for the extinguishment or redemption of a front foot benefit charge by a~~  
10 ~~certain amount under certain circumstances; requiring, beginning on a certain~~  
11 ~~date, certain information regarding the number of payments of a front foot~~  
12 ~~benefit charge to be printed on property tax bills in Prince George's County;~~  
13 ~~prohibiting the Commission from assessing a benefit charge against certain real~~  
14 ~~property for longer than a certain number of years under certain circumstances;~~  
15 ~~prohibiting the Commission from recalculating or increasing any benefit charge~~  
16 ~~assessed against property because of a reduction of the revenues collected by the~~

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

(a) ~~The Commission may issue bonds of the sanitary district in amounts necessary to carry on its work, including for:~~

(1) ~~acquisition, design, construction, reconstruction, establishment, extension, enlargement, or condemnation of the water and sewer systems in the sanitary district or in an area where extension of the systems may be authorized by law;~~

3 ~~administer or operate the systems; or~~

10           ~~(b) (1) The Commission may issue bonds of the sanitary district for the~~

9 (a) This section applies to the collection of benefit charges for the  
10 Commission by the directors of finance of Prince George's County and Montgomery  
11 County or by other tax collecting authorities in those counties.

12 (b) Each year, for 30 days before the collection of taxes begins in  
13 Montgomery County and Prince George's County, the Commission shall have access to  
14 the records of the treasury division in each county's department or office of finance to  
15 inform each county:

16 (1) regarding which properties or property owners are subject to a  
17 benefit charge and the annual benefit charge imposed on the property;

18 (2) regarding each property on which the Commission has imposed a  
19 benefit charge that was not subject to State or county taxes; and

20 (3) of the total benefit charge imposed for all properties in the county.

21 (c) (1) (i) All laws relating to the collection of county taxes apply to  
22 the collection of a benefit charge.

23 (ii) A benefit charge:

24 1. for purposes of collection, shall be treated as a county  
25 tax;

26 2. shall bear the same interest and penalties as a county

28 3. shall be advertised with, and in the same manner as,

1 (3) The director of finance:

2 (i) shall refer a protest, objection, or complaint concerning a  
3 benefit charge to the Commission; and

4 (ii) may not refund, change, or amend a benefit charge.

5 (4) A property redeemed from a county tax sale or a property sold by  
6 the county council of Montgomery County or Prince George's County after a final tax  
7 sale may not be redeemed or sold except on payment of the benefit charge due on the  
8 property.

9 (5) A property subject to a delinquent benefit charge shall be sold for  
10 the delinquent benefit charge at the same time and in the same manner as property  
11 sold for delinquent county taxes.

12 (d) (1) The director of finance shall:

13 (i) print on the tax bill:

14 "To Sanitary Commission benefit charge \$...";

15 (ii) provide a space on the tax bill for the interest or penalty;

16 (iii) make the proper entries on each tax bill mailed; and

17 (iv) collect the amount specified on the bill for the benefit charge  
18 with the State and county taxes.

19 (2) In Montgomery County, each property tax bill shall list separately  
20 any deferred water main or sewer connection benefit charges applicable to an assessed  
21 property.

22 **(3) ~~IN~~ BEGINNING JUNE 1, 2013, IN PRINCE GEORGE'S COUNTY,**  
23 **EACH PROPERTY TAX BILL SHALL CONTAIN A NOTICE OF THE NUMBER OF**

2 amount due to the Commission.

4 County shall require the bonds of its respective director of finance to be conditioned on  
5 payment to the Commission of the amount collected under this section.

6 (f) (1) By December 1 of each year, the Commission shall pay  
7 Montgomery County and Prince George's County a reasonable amount for the services  
8 of its respective director of finance.

9 (2) The payment provided for in paragraph (1) of this subsection shall

2                    (1)    one member from the delegation to the Senate of Maryland from  
3 Montgomery County, selected by the chair of the delegation;

4                    (2)    one member from the delegation to the Senate of Maryland from  
5 Prince George's County, selected by the chair of the delegation;

6                    (3)    one member from the delegation to the House of Delegates from  
7 Montgomery County, appointed by the chair of the delegation;

8                    (4)    one member from the delegation to the House of Delegates from  
9 Prince George's County, appointed by the chair of the delegation;

10                   (5)    one member who has experience in finance designated by the  
11 County Executive of Montgomery County;

12                   (6)    one member who has experience in finance designated by the  
13 County Executive of Prince George's County;

14                   (7)    one member who has experience in finance designated by the  
15 Montgomery County Council;

16                   (8)    one member who has experience in finance designated by the  
17 Prince George's County Council;

18                   (9)    the chair of the Washington Suburban Sanitary Commission, or  
19 the chair's designee; and

20                   (10)  the following members appointed by the Governor:

21                            (i)    one representative of the Maryland–National Capital  
22 Building Industry Association;

23                            (ii)   one representative of a land developer in the Washington  
24 Suburban Sanitary District in Prince George's County; and

2           (2)   is entitled to reimbursement for expenses under the Standard

5 information and documents to the Task Force that the Task Force requires to carry

12 increases charged by the Washington Suburban Sanitary Commission with the rates  
13 charged by water and sewer public utilities in other states;

16           (i)   implemented a cap on the percentage that the Washington
