## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Medical Assistance Program – Subrogation – Reduction**

3 FOR the purpose of requiring under certain circumstances that the amount for which  
4 the Department of Health and Mental Hygiene has a right of subrogation for  
5 health care benefits or services paid or payable on behalf of a Maryland Medical  
6 Assistance Program recipient be reduced by a certain amount related to the  
7 amount of certain attorney’s fees incurred by the Program recipient; specifying  
8 that the amount for which the Department has a right of subrogation may not  
9 be reduced beyond a certain percentage; repealing a certain provision of law  
10 granting certain immunity to the Department; repealing a certain provision of  
11 law relating to a deduction of certain fees and certain costs from certain money  
12 received by a Program recipient; authorizing the Department to compromise or  
13 settle and release certain subrogation claims under certain circumstances; and  
14 generally relating to the Maryland Medical Assistance Program and  
15 subrogation claims.

16 BY repealing and reenacting, with amendments,  
17 Article – Health – General

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
22 MARYLAND, That the Laws of Maryland read as follows:

23 **Article – Health – General**

24 15–120.

1 (a) If a Program recipient has a cause of action against a person, the  
2 Department shall be subrogated to that cause of action to the extent of any payments  
3 made by the Department on behalf of the Program recipient that result from the  
4 occurrence that gave rise to the cause of action.

5 (b) (1) An attorney representing a Program recipient in a cause of action  
6 to which the Department has a right of subrogation shall notify the Department prior  
7 to filing a claim, commencing an action, or negotiating a settlement.

8 (2) The attorney shall notify the Department in advance of the  
9 resolution of a cause of action and shall allow the Department 3 business days from  
10 the receipt of the notice to establish its subrogated interest.

11 (3) This subsection may not be construed to create a cause of action for  
12 notifying or failing to notify the Department.

13 (c) (1) Any Program recipient or attorney, guardian, or personal  
14 representative of a Program recipient who receives money in settlement of or under a  
15 judgment or award in a cause of action in which the Department has a subrogation  
16 claim shall, after receiving written notice of the subrogation claim, hold that money,  
17 for the benefit of the Department, to the extent required for the subrogation claim,  
18 after deducting applicable attorney fees and litigation costs.

19 (2) A person who, after written notice of a subrogation claim and  
20 possible liability under this paragraph, disposes of the money, without the written  
21 approval of the Department, is liable to the Department for any amount that, because  
22 of the disposition, is not recoverable by the Department.

23 (3) **(I) THIS PARAGRAPH APPLIES TO A VOLUNTARY**  
24 **REDUCTION OF A SUBROGATION CLAIM BY THE DEPARTMENT THAT EXCEEDS**  
25 **THE REDUCTION OF THE SUBROGATION CLAIM UNDER PARAGRAPH (4) OF THIS**  
26 **SUBSECTION.**

27 **(II)** The Department may compromise or settle and release its  
28 subrogation claim if, in its judgment, collection of the claim will cause substantial  
29 hardship:

30 **[(i)] 1.** To the Program recipient;

31 **2. TO A TRUST CREATED FOR THE BENEFIT OF THE**  
32 **PROGRAM RECIPIENT; or**

33 **[(ii)] 3.** In a wrongful death action, to the surviving  
34 dependents of a deceased Program recipient.

1           [(4) (i) The Department is not liable for payment of or contribution  
2 to any attorney fees or litigation costs of any Program recipient or attorney, guardian,  
3 or personal representative of any Program recipient.

4           (ii) The deduction of applicable attorney fees and litigation costs  
5 under paragraph (1) of this subsection may not be considered as payment for or  
6 contribution to those fees or costs by the Department.]

7           **(4) (I) THIS PARAGRAPH APPLIES TO ALL SUBROGATION**  
8 **INTERESTS HELD BY THE DEPARTMENT, INCLUDING SUBROGATION INTERESTS**  
9 **PAYABLE ON BEHALF OF A PROGRAM RECIPIENT BY A TRUST OR BY**  
10 **BENEFICIARIES OF A DECEASED PROGRAM RECIPIENT IN A WRONGFUL DEATH**  
11 **ACTION.**

12           **(II) UNLESS THE DEPARTMENT FILES A PETITION TO**  
13 **INTERVENE IN A CAUSE OF ACTION TO WHICH THE DEPARTMENT HAS A**  
14 **SUBROGATION CLAIM AND IS INDEPENDENTLY REPRESENTED BY COUNSEL, THE**  
15 **AMOUNT PERMITTED TO BE RECOVERED BY THE DEPARTMENT FOR HEALTH**  
16 **CARE BENEFITS OR SERVICES PAID OR PAYABLE ON BEHALF OF THE PROGRAM**  
17 **RECIPIENT SHALL BE REDUCED BY THE AMOUNT THAT IS DETERMINED BY:**

18           **1. SUBJECT TO SUBPARAGRAPH (III) OF THIS**  
19 **PARAGRAPH, DIVIDING THE AMOUNT OF THE TOTAL RECOVERY IN THE CAUSE**  
20 **OF ACTION INTO THE TOTAL AMOUNT OF THE ATTORNEY'S FEES INCURRED BY**  
21 **THE PROGRAM RECIPIENT FOR SERVICES RENDERED IN CONNECTION WITH THE**  
22 **CAUSE OF ACTION; AND**

23           **2. MULTIPLYING THE RESULT UNDER ITEM 1 OF**  
24 **THIS SUBPARAGRAPH BY THE AMOUNT OF THE DEPARTMENT'S SUBROGATION**  
25 **CLAIM.**

26           **(III) THE PERCENTAGE UNDER SUBPARAGRAPH (II)1 OF**  
27 **THIS PARAGRAPH MAY NOT EXCEED ONE-THIRD.**

28           (d) Any action brought under this section is not exclusive and is independent  
29 of and in addition to any right, remedy, or cause of action available to the State, the  
30 Department, any other State agency, or a Program recipient or any other individual.

31           (e) (1) (i) In this subsection the following words have the meanings  
32 indicated.

33           (ii) "Cigarette" means any roll of tobacco wrapped in:

34           1. Paper;
