## A BILL ENTITLED

1 AN ACT concerning

2 **Calvert County – Annual Financial Report – Filing Date**

3 FOR the purpose of altering the date by which Calvert County may file its annual  
4 financial report for the fiscal year with the Department of Legislative Services;  
5 and generally relating to the annual financial report of Calvert County.

6 BY repealing and reenacting, with amendments,  
7 Article 19 – Comptroller  
8 Section 37  
9 Annotated Code of Maryland  
10 (2011 Replacement Volume)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article 19 – Comptroller**

14 37.

15 (a) (1) Except as provided in paragraph (2) of this subsection, each  
16 county, municipal corporation, and taxing district in the State shall by the first day of  
17 November after the close of the fiscal year file with the Department of Legislative  
18 Services its financial report covering the full period of that fiscal year.

19 (2) (i) Each county, municipal corporation, or taxing district with a  
20 population of more than 400,000 may by the first day of January after the close of the  
21 fiscal year file with the Department of Legislative Services its financial report  
22 covering the full period of that fiscal year.

23 (ii) Unless subparagraph (i) of this paragraph applies, Howard  
24 County may by the first day of December after the close of the fiscal year file with the

1 Department of Legislative Services its financial report covering the full period of that  
2 fiscal year.

3 (iii) **CALVERT COUNTY MAY BY THE FIRST DAY OF JANUARY**  
4 **AFTER THE CLOSE OF THE FISCAL YEAR FILE WITH THE DEPARTMENT OF**  
5 **LEGISLATIVE SERVICES ITS FINANCIAL REPORT COVERING THE FULL PERIOD**  
6 **OF THAT FISCAL YEAR.**

7 (IV) Frederick County may by the first day of January after the  
8 close of the fiscal year file with the Department of Legislative Services its financial  
9 report covering the full period of that fiscal year.

10 [(iv)] (V) Queen Anne's County may by the first day of January  
11 after the close of the fiscal year file with the Department of Legislative Services its  
12 financial report covering the full period of that fiscal year.

13 [(v)] (VI) St. Mary's County may by the first day of January  
14 after the close of the fiscal year file with the Department of Legislative Services its  
15 financial report covering the full period of that fiscal year.

16 [(vi)] (VII) Wicomico County may by the first day of January  
17 after the close of the fiscal year file with the Department of Legislative Services its  
18 financial report covering the full period of that fiscal year.

19 (b) The reports required by subsection (a) of this section shall be:

20 (1) Properly filled in on the form or forms established by the  
21 Department as provided in this subtitle; and

22 (2) Verified by the chief executive officer of each county, municipal  
23 corporation, and taxing district.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
25 October 1, 2012.
