### Calvert County – Annual Financial Report – Filing Date

- FOR the purpose of altering the date by which Calvert County may file its annual
   financial report for the fiscal year with the Department of Legislative Services;
   and generally relating to the annual financial report of Calvert County.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12 MARYLAND, That the Laws of Maryland read as follows:

## Article 19 – Comptroller

(a) (1) Except as provided in paragraph (2) of this subsection, each
county, municipal corporation, and taxing district in the State shall by the first day of
November after the close of the fiscal year file with the Department of Legislative
Services its financial report covering the full period of that fiscal year.

1 (2) (i) Each county, municipal corporation, or taxing district with a 2 population of more than 400,000 may by the first day of January after the close of the 3 fiscal year file with the Department of Legislative Services its financial report 4 covering the full period of that fiscal year.

5 (ii) Unless subparagraph (i) of this paragraph applies, Howard 6 County may by the first day of December after the close of the fiscal year file with the 7 Department of Legislative Services its financial report covering the full period of that 8 fiscal year.

### 9 (iii) CALVERT COUNTY MAY BY THE FIRST DAY OF JANUARY 10 AFTER THE CLOSE OF THE FISCAL YEAR FILE WITH THE DEPARTMENT OF 11 LEGISLATIVE SERVICES ITS FINANCIAL REPORT COVERING THE FULL PERIOD 12 OF THAT FISCAL YEAR.

13 (IV) Frederick County may by the first day of January after the 14 close of the fiscal year file with the Department of Legislative Services its financial 15 report covering the full period of that fiscal year.

[(iv)] (V) Queen Anne's County may by the first day of January
after the close of the fiscal year file with the Department of Legislative Services its
financial report covering the full period of that fiscal year.

19 [(v)] (VI) St. Mary's County may by the first day of January 20 after the close of the fiscal year file with the Department of Legislative Services its 21 financial report covering the full period of that fiscal year.

[(vi)] (VII) Wicomico County may by the first day of January after the close of the fiscal year file with the Department of Legislative Services its financial report covering the full period of that fiscal year.

- 25 (b) The reports required by subsection (a) of this section shall be:
- 26 (1) Properly filled in on the form or forms established by the 27 Department as provided in this subtitle; and

(2) Verified by the chief executive officer of each county, municipal
 corporation, and taxing district.
