## A BILL ENTITLED

1 AN ACT concerning

2 **Washington County – Tip Jars – Accountability and Oversight**

3 FOR the purpose of authorizing the County Commissioners of Washington County to  
4 require the Washington County Volunteer Fire and Rescue Association to  
5 submit certain financial reports; authorizing the county commissioners to adopt  
6 certain regulations; authorizing the county commissioners to withhold certain  
7 funds under certain circumstances; requiring the Washington County Volunteer  
8 Fire and Rescue Association to submit its budget to the county commissioners  
9 each year; requiring the county commissioners to accept or reject the budget in  
10 a certain manner; expanding the authority of the county commissioners to  
11 establish certain procedures; prohibiting certain funds from being used for  
12 certain fire and rescue services; and generally relating to the use of certain tip  
13 jar gaming proceeds in Washington County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That the Laws of Maryland read as follows:

21 **Article – Criminal Law**

22 13–2435.

23 (a) In this section, “gross profits” means the total proceeds from the  
24 operation of a tip jar less the amount of money winnings or value of prizes distributed.

25 (b) There is a Washington County Gaming Fund.

1 (c) (1) The county commissioners shall establish:

2 (i) the method and time of deposits to the fund; and

3 (ii) other procedures necessary to carry out subsections [(d) and  
4 (e)] **(D), (E), AND (F)** of this section.

5 (2) In accordance with a written agreement between the county  
6 commissioners and the gaming commission, the gaming commission may use money  
7 from the fund to reimburse the county commissioners for the costs to the county for  
8 administering Part III of this subtitle.

9 **(3) (I) THE COUNTY COMMISSIONERS MAY REQUIRE THE  
10 WASHINGTON COUNTY VOLUNTEER FIRE AND RESCUE ASSOCIATION TO  
11 SUBMIT FINANCIAL REPORTS OF THE ASSOCIATION.**

12 **(II) THE COUNTY COMMISSIONERS MAY ADOPT  
13 REGULATIONS SPECIFYING THE TIME FRAMES FOR SUBMISSION OF THE  
14 REPORTS, BUT THE REGULATIONS SHALL BE LIMITED IN SCOPE TO THE TIMING  
15 OF SUBMISSION OF THE REPORTS ONLY.**

16 **(III) THE FINANCIAL REPORTS OF THE WASHINGTON  
17 COUNTY VOLUNTEER FIRE AND RESCUE ASSOCIATION MAY INCLUDE AN  
18 ANNUAL BUDGET AS APPROVED UNDER PARAGRAPH (4) OF THIS SUBSECTION,  
19 BUDGET REPORTS, AND RELATED DOCUMENTATION THAT SHOWS HOW MONEY  
20 HAS BEEN SPENT BY THE WASHINGTON COUNTY VOLUNTEER FIRE AND  
21 RESCUE ASSOCIATION DURING THE PREVIOUS FISCAL YEAR.**

22 **(IV) IF THE FINANCIAL REPORTS ARE NOT SUBMITTED  
23 WITHIN THE TIME REQUIRED UNDER THE REGULATIONS, THE COUNTY  
24 COMMISSIONERS MAY WITHHOLD FUNDS THAT WOULD OTHERWISE BE  
25 DISTRIBUTED UNDER SUBSECTION (F)(1) OF THIS SECTION UNTIL THE REPORTS  
26 ARE SUBMITTED.**

27 **(4) (I) EACH YEAR THE WASHINGTON COUNTY VOLUNTEER  
28 FIRE AND RESCUE ASSOCIATION SHALL SUBMIT ITS BUDGET TO THE COUNTY  
29 COMMISSIONERS.**

30 **(II) THE COUNTY COMMISSIONERS SHALL ACCEPT OR  
31 REJECT THE BUDGET BY A MAJORITY VOTE.**

32 **(III) THE ACCEPTANCE OR REJECTION OF THE BUDGET MAY  
33 NOT BE DELEGATED TO ANY DESIGNEE.**

1                   **(IV) THE COUNTY COMMISSIONERS MAY WITHHOLD FUNDS**  
2 **THAT WOULD OTHERWISE BE DISTRIBUTED UNDER SUBSECTION (F)(1) OF THIS**  
3 **SECTION UNTIL THE BUDGET OF THE WASHINGTON COUNTY VOLUNTEER FIRE**  
4 **AND RESCUE ASSOCIATION IS ACCEPTED BY THE COUNTY COMMISSIONERS.**

5           (d)   (1)   This subsection applies only to a person who holds a tip jar license  
6 under § 13–2420(b)(7), (8), or (9) of this subtitle.

7           (2)   Subject to paragraph (3) of this subsection, a person subject to this  
8 subsection shall deposit with a financial institution designated by the gaming  
9 commission, to the credit of the fund, the gross profits from each tip jar that the  
10 person operates.

11           (3)   To offset the costs of operating a tip jar, a person with a tip jar  
12 license may retain the lesser of \$45 or 50% of the gross profits from each tip jar game.

13           (e)   (1)   This subsection applies only to a person who holds a tip jar license  
14 under § 13–2420(b)(1) through (6) of this subtitle.

15           (2)   A person subject to this subsection shall deposit with a financial  
16 institution designated by the gaming commission, to the credit of the fund, 15% of the  
17 gross profits earned through the operation of tip jars during the 12–month period  
18 ending June 30.

19           (3)   If a person fails to contribute the full amount required under  
20 paragraph (2) of this subsection, the person shall deposit the balance required during  
21 the next year.

22           (f)   After the reimbursement under subsection (c)(2) of this section, each year  
23 the gaming commission shall distribute:

24           (1)   50% of the money deposited in the fund to the Washington County  
25 Volunteer Fire and Rescue Association; and

26           (2)   subject to any restriction that the county commissioners adopt by  
27 regulation, 50% of the money deposited in the fund to bona fide charitable  
28 organizations in the county.

29                   **(G) THE COUNTY COMMISSIONERS MAY NOT REQUIRE THAT FUNDS**  
30 **DISTRIBUTED UNDER (F)(1) OF THIS SECTION BE USED FOR FIRE AND RESCUE**  
31 **SERVICES FOR WHICH FUNDS PREVIOUSLY HAVE BEEN APPROPRIATED IN THE**  
32 **COUNTY OPERATING BUDGET.**

33           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
34 October 1, 2012.
