1 AN ACT concerning

2 **Election Law – Campaign Finance Entities – Retention of Records**

3 FOR the purpose of altering record retention requirements applicable to campaign
4 finance entities by requiring that the account books and related records of a
5 campaign finance entity be preserved until the earlier of a certain number of
6 years after the creation of the record or a certain number of years after the
7 campaign finance entity files a final campaign finance report; and generally
8 relating to record retention by campaign finance entities.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Election Law**

18 (a) (1) The treasurer of a campaign finance entity shall keep a detailed
19 and accurate account book of all assets received, expenditures made, and obligations
20 incurred by or on behalf of the entity.

1 (2) Except as provided in § 13–240 of this subtitle, as to each asset
2 received or expenditure made, the account book shall state:

3 (i) its amount or value;

4 (ii) the date of the receipt or expenditure;

5 (iii) the name and address of the person from whom the asset
6 was received or to whom the expenditure was made; and

7 (iv) a description of the asset received or the purpose for which
8 the expenditure was made.

9 (3) Each expenditure made from a campaign account shall be
10 supported by a receipt.

11 (b) The account books and related records of a campaign finance entity shall
12 be preserved until **THE EARLIER OF:**

13 **(1) 10 YEARS AFTER THE CREATION OF AN ACCOUNT BOOK ENTRY**
14 **OR RELATED RECORD; OR**

15 **(2) 2 years after the campaign finance entity files a final campaign**
16 **finance report under Subtitle 3 of this title.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 June 1, 2012.
