BY repealing and reenacting, with amendments. Article - Election Law Section 13–221 Annotated Code of Maryland (2010 Replacement Volume and 2011 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Election Law 13 - 221.(a) (1) The treasurer of a campaign finance entity shall keep a detailed and accurate account book of all assets received, expenditures made, and obligations incurred by or on behalf of the entity.

3	(i) its amount or value;
4	(ii) the date of the receipt or expenditure;
5 6	(iii) the name and address of the person from whom the asset was received or to whom the expenditure was made; and
7 8	(iv) a description of the asset received or the purpose for which the expenditure was made.
9 10	(3) Each expenditure made from a campaign account shall be supported by a receipt.
11 12	(b) The account books and related records of a campaign finance entity shall be preserved until THE EARLIER OF:
13 14	(1) 10 YEARS AFTER THE CREATION OF AN ACCOUNT BOOK ENTRY OR RELATED RECORD; OR
15 16	(2) 2 years after the campaign finance entity files a final campaign finance report under Subtitle 3 of this title.
17 18	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2012.
