## A BILL ENTITLED

1 AN ACT concerning

2 **Higher Education – Tuition Waiver – Children of Law Enforcement Officers**  
3 **Killed in the Line of Duty**

4 FOR the purpose of waiving tuition and mandatory fees for children of State or local  
5 law enforcement officers killed in the line of duty who attend a public  
6 institution of higher education under certain circumstances; setting forth the  
7 conditions for receiving the waiver; exempting a certain child from paying the  
8 difference between certain amounts; providing for the duration of the waiver;  
9 requiring the Maryland Higher Education Commission to adopt certain  
10 regulations; defining certain terms; and generally relating to a tuition waiver  
11 for children of law enforcement officers killed in the line of duty in the State.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Education**

4 **15-106.9.**

5 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE  
6 MEANINGS INDICATED.

7 (2) “LAW ENFORCEMENT OFFICER” MEANS A LAW ENFORCEMENT  
8 OFFICER AS DEFINED IN § 3-101 OF THE PUBLIC SAFETY ARTICLE.

9 (3) (I) “TUITION” MEANS THE CHARGES IMPOSED BY A PUBLIC  
10 INSTITUTION OF HIGHER EDUCATION FOR ENROLLMENT AT THE INSTITUTION.

11 (II) “TUITION” INCLUDES CHARGES FOR REGISTRATION  
12 AND ALL FEES REQUIRED AS A CONDITION OF ENROLLMENT.

13 (B) (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE,  
14 BEGINNING WITH THE 2012 FALL SEMESTER, THE CHILD OF A STATE OR LOCAL  
15 LAW ENFORCEMENT OFFICER KILLED IN THE LINE OF DUTY WHO ATTENDS A  
16 PUBLIC INSTITUTION OF HIGHER EDUCATION IN THE STATE IS EXEMPT FROM  
17 PAYING TUITION AT THE PUBLIC INSTITUTION OF HIGHER EDUCATION IN THIS  
18 STATE IF:

19 (I) THE CHILD IS ENROLLED AT THE INSTITUTION ON OR  
20 BEFORE THE DATE THAT THE CHILD REACHES THE AGE OF 25 YEARS; AND

21 (II) THE CHILD HAS FILED FOR FEDERAL AND STATE  
22 FINANCIAL AID BY MARCH 1 EACH YEAR.

23 (2) IF A CHILD DESCRIBED IN PARAGRAPH (1) OF THIS  
24 SUBSECTION RECEIVES A SCHOLARSHIP OR GRANT FOR POSTSECONDARY  
25 STUDY AT A PUBLIC INSTITUTION OF HIGHER EDUCATION, THE CHILD MAY NOT  
26 BE REQUIRED TO PAY THE DIFFERENCE BETWEEN THE AMOUNT OF THE  
27 SCHOLARSHIP OR GRANT AND THE AMOUNT OF THE TUITION.

28 (3) A CHILD WHO IS EXEMPT FROM TUITION UNDER THIS  
29 SECTION CONTINUES TO BE EXEMPT UNTIL THE EARLIER OF:

30 (I) 5 YEARS AFTER FIRST ENROLLING AS A CANDIDATE FOR  
31 AN ASSOCIATE’S DEGREE OR A BACHELOR’S DEGREE AT A PUBLIC INSTITUTION  
32 OF HIGHER EDUCATION IN THE STATE; OR

1                   **(II) THE DATE THAT THE CHILD IS AWARDED A BACHELOR’S**  
2 **DEGREE.**

3           **(C) THE COMMISSION SHALL ADOPT REGULATIONS IN ACCORDANCE**  
4 **WITH TITLE 10, SUBTITLE 1 OF THE STATE GOVERNMENT ARTICLE TO**  
5 **IMPLEMENT THE PROVISIONS OF THIS SECTION.**

8           (e) (1) “Law enforcement officer” means an individual who:

9                           (i) in an official capacity is authorized by law to make arrests;  
10 and

11                           (ii) is a member of one of the following law enforcement  
12 agencies:

- 13                                   1. the Department of State Police;
- 14                                   2. the Police Department of Baltimore City;
- 15                                   3. the Baltimore City School Police Force;
- 16                                   4. the Baltimore City Watershed Police Force;
- 17                                   5. the police department, bureau, or force of a county;
- 18                                   6. the police department, bureau, or force of a municipal  
19 corporation;
- 20                                   7. the office of the sheriff of a county;
- 21                                   8. the police department, bureau, or force of a bicounty  
22 agency;
- 23                                   9. the Maryland Transportation Authority Police;
- 24                                   10. the police forces of the Department of Transportation;
- 25                                   11. the police forces of the Department of Natural  
26 Resources;

- 1    12.    the Field Enforcement Bureau of the Comptroller’s  
 2 Office;
- 3    13.    the Housing Authority of Baltimore City Police Force;
- 4    14.    the Crofton Police Department;
- 5    15.    the police force of the Department of Health and  
 6 Mental Hygiene;
- 7    16.    the police force of the Department of General  
 8 Services;
- 9    17.    the police force of the Department of Labor, Licensing,  
 10 and Regulation;
- 11     18.    the police forces of the University System of  
 12 Maryland;
- 13     19.    the police force of Morgan State University;
- 14     20.    the office of State Fire Marshal;
- 15     21.    the Ocean Pines Police Department;
- 16     22.    the police force of the Baltimore City Community  
 17 College;
- 18     23.    the police force of the Hagerstown Community  
 19 College;
- 20     24.    the Internal Investigation Unit of the Department of  
 21 Public Safety and Correctional Services; or
- 22     25.    the Warrant Apprehension Unit of the Division of  
 23 Parole and Probation in the Department of Public Safety and Correctional Services.
- 24     (2)    “Law enforcement officer” does not include:
- 25     (i)    an individual who serves at the pleasure of the Police  
 26 Commissioner of Baltimore City;
- 27     (ii)    an individual who serves at the pleasure of the appointing  
 28 authority of a charter county;
- 29     (iii)    the police chief of a municipal corporation;

1 (iv) an officer who is in probationary status on initial entry into  
2 the law enforcement agency except if an allegation of brutality in the execution of the  
3 officer's duties is made;

4 (v) a Montgomery County fire and explosive investigator as  
5 defined in § 2-208.1 of the Criminal Procedure Article;

6 (vi) an Anne Arundel County or City of Annapolis fire and  
7 explosive investigator as defined in § 2-208.2 of the Criminal Procedure Article;

8 (vii) a Prince George's County fire and explosive investigator as  
9 defined in § 2-208.3 of the Criminal Procedure Article;

10 (viii) a Worcester County fire and explosive investigator as  
11 defined in § 2-208.4 of the Criminal Procedure Article; or

12 (ix) a City of Hagerstown fire and explosive investigator as  
13 defined in § 2-208.5 of the Criminal Procedure Article.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
15 July 1, 2012.
