# 2 Workers' Compensation – Emergency Responders – Revisions

3 FOR the purpose of altering the definition of "on duty" in the workers' compensation 4 law to include the performance of certain duties assigned to certain individuals  $\mathbf{5}$ appointed as deputy sheriffs or members of a certain fire police unit; altering 6 the definition of "volunteer company" to include a volunteer fire police unit; 7 specifying that a certain yearly stipend to help offset out-of-pocket expenses 8 that is paid to certain emergency responders may not be used when determining 9 the average weekly wage of the members for workers' compensation purposes; 10 specifying that certain emergency responders who receive a certain membership benefit may not be considered *paid covered* employees for a certain purpose 11 based on receipt of a certain membership benefit; and generally relating to 1213workers' compensation for emergency responders.
