2 Physicians – Sharing of Information with Maryland Health Care Commission

- 3 FOR the purpose of adding the Maryland Health Care Commission to the list of 4 entities to which the Health Services Cost Review Commission may disclose $\mathbf{5}$ certain physician information; requiring the State Board of Physicians to 6 disclose information contained in a record to the Maryland Health Care 7 Commission for a certain purpose; adding the Maryland Health Care 8 Commission to the list of entities that must adopt regulations for a certain 9 transfer of information in a record; altering the date by which the regulations 10 must be adopted; and generally relating to sharing information about physicians with the Maryland Health Care Commission for the purpose of 11 identifying practice patterns and investigating quality or utilization of care in 12 certain regulated entities. 13

1 Except as otherwise expressly provided in this section and § 14–411.1 of (b) $\mathbf{2}$ this subtitle, the Board or any of its investigatory bodies may not disclose any 3 information contained in a record. (d) The Board shall disclose any information contained in a record to: 4 $\mathbf{5}$ (1)A committee of a hospital, health maintenance organization, or 6 related institution if: 7The committee of a medical hospital staff concerned with (i) 8 physician discipline or other committee of a hospital, health maintenance 9 organization, or related institution requests the information in writing; 10 The Board has issued an order as to a licensed physician on (ii) whom the information is requested; and 11 12(iii) The Board determines that the information requested is 13necessary for an investigation or action of the committee as to a medical privilege of a 14licensed physician; or 15The Secretary, the Office of Health Care Quality in the (2)Department, THE MARYLAND HEALTH CARE COMMISSION, or the Health Services 16 17Cost Review Commission for the purpose of investigating quality of utilization of care 18in any entity regulated by the Office of Health Care Quality or the Health Services 19Cost Review Commission. 20(e) On or before January 1, [2012] 2013, the Board, the Secretary, THE 21MARYLAND HEALTH CARE COMMISSION, and the Health Services Cost Review 22Commission jointly shall adopt regulations for the efficient and secure transfer, under 23subsection (d)(2) of this section, of any information in a record that may indicate that 24an investigation of an entity regulated by the Office of Health Care Quality, THE

25 MARYLAND HEALTH CARE COMMISSION, or the Health Services Cost Review 26 Commission may be appropriate.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect28 July 1, 2012.
