## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **State Department of Education – Lacrosse Opportunities Program**

3 FOR the purpose of creating the Lacrosse Opportunities Program in the State  
4 Department of Education to increase opportunities for minority students to  
5 participate in lacrosse in their communities; requiring the State Superintendent  
6 of Education to administer the Program; authorizing certain local education  
7 agencies to submit an application for a grant under the Program; requiring a  
8 grant application to include certain information; requiring the Department, in  
9 making grants under the Program, to require certain matching funds from  
10 certain sources; limiting the amount of a grant under the Program; requiring  
11 the State Superintendent or the State Superintendent’s designee to review  
12 applications and provide grants to eligible agencies with programs that will  
13 increase opportunities for minority students to participate in lacrosse; requiring  
14 the Governor to include a certain amount for the Program in each annual  
15 budget submission; requiring the State Superintendent to adopt certain  
16 regulations; defining certain terms; and generally relating to the Lacrosse  
17 Opportunities Program to increase opportunities for minority students to  
18 participate in lacrosse in their communities.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Education**

4 **2–305.**

5 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE  
6 MEANINGS INDICATED.

7 (2) “AGENCY” MEANS A LOCAL EDUCATION AGENCY SERVING A  
8 POPULATION OF STUDENTS AT LEAST 80% OF WHICH ARE MINORITY STUDENTS.

9 (3) “MINORITY STUDENT” HAS THE MEANING STATED IN  
10 REGULATIONS ADOPTED BY THE STATE SUPERINTENDENT.

11 (B) (1) THERE IS A LACROSSE OPPORTUNITIES PROGRAM IN THE  
12 DEPARTMENT.

13 (2) THE PURPOSE OF THE LACROSSE OPPORTUNITIES PROGRAM  
14 IS TO INCREASE OPPORTUNITIES FOR MINORITY STUDENTS TO PARTICIPATE IN  
15 LACROSSE IN THEIR COMMUNITIES.

16 (C) THE STATE SUPERINTENDENT SHALL DEVELOP AND ADMINISTER  
17 THE LACROSSE OPPORTUNITIES PROGRAM.

18 (D) (1) AN AGENCY MAY SUBMIT AN APPLICATION TO THE  
19 DEPARTMENT TO RECEIVE A GRANT FOR A PROGRAM THAT IS IN FURTHERANCE  
20 OF THE PURPOSE OF THE LACROSSE OPPORTUNITIES PROGRAM.

21 (2) AN APPLICATION SHALL INCLUDE:

22 (I) A DESCRIPTION OF THE SCOPE AND PURPOSE OF THE  
23 PROPOSED PROGRAM;

24 (II) A BUSINESS PLAN THAT INCLUDES THE ESTIMATED  
25 TOTAL COST OF THE PROPOSED PROGRAM; AND

26 (III) ANY OTHER INFORMATION REQUIRED BY THE  
27 DEPARTMENT.

28 (E) IN AWARDING A GRANT UNDER THE LACROSSE OPPORTUNITIES  
29 PROGRAM, THE DEPARTMENT SHALL:

1           **(1) REQUIRE THE GRANTEE TO PROVIDE MATCHING FUNDS FROM**  
2 **ANY COMBINATION OF FEDERAL, COUNTY, MUNICIPAL, OR PRIVATE SOURCES;**  
3 **AND**

4           **(2) ENSURE THAT THE GRANT DOES NOT EXCEED 50% OF THE**  
5 **TOTAL ANNUAL COST OF THE GRANTEE’S PROGRAM.**

6           **(F) THE STATE SUPERINTENDENT OR THE STATE SUPERINTENDENT’S**  
7 **DESIGNEE SHALL:**

8                   **(1) REVIEW GRANT APPLICATIONS SUBMITTED IN ACCORDANCE**  
9 **WITH SUBSECTION (D) OF THIS SECTION; AND**

10                   **(2) TO THE EXTENT FUNDS ARE AVAILABLE, PROVIDE GRANTS TO**  
11 **AGENCIES THAT MEET THE REQUIREMENTS FOR A GRANT UNDER THIS SECTION.**

12           **(G) FOR FISCAL YEAR 2014 AND EACH FISCAL YEAR THEREAFTER, THE**  
13 **GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET SUBMISSION AT LEAST**  
14 **~~\$100,000~~ \$40,000 FOR THE LACROSSE OPPORTUNITIES PROGRAM.**

15           **(H) THE STATE SUPERINTENDENT SHALL ADOPT REGULATIONS TO**  
16 **IMPLEMENT THIS SECTION.**

17           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
18 June 1, 2012.
