## 1 AN ACT concerning

## **Environment - Asbestos Worker Protection**

3 FOR the purpose of adding to the General Assembly's findings related to protecting 4 the safety of asbestos removers; requiring the Department of the Environment 5 to verify certain information before accrediting an individual to engage in an 6 asbestos occupation; authorizing the Department to include the costs of 7 examination administration in setting certain fees; increasing the maximum 8 penalty that may be imposed for certain violations; establishing a minimum penalty under a certain circumstance; requiring certain penalties and fines to 9 be paid into the Asbestos Worker Protection Fund and providing for the uses of 10 the Fund; establishing the Fund as a special, nonlapsing fund; requiring the 11 12 Department to administer the Fund; requiring the State Treasurer to hold the 13 Fund and the Comptroller to account for the Fund; specifying the contents of 14 the Fund; providing for the investment of money in and expenditures from the 15 Fund; exempting certain interest earnings from a requirement that certain 16 interest accrue to the General Fund; altering the definition of a certain term; 17 defining a certain term; and generally relating to asbestos worker protection.
