A BILL ENTITLED

1 AN ACT concerning

2 **Transportation – Institutions of Higher Education and State Employment**
3 **Facilities – Bicycle and Pedestrian Access**

4 FOR the purpose of requiring each public institution of higher education and State
5 employment facility to develop on or before a certain date a facility master plan
6 to address bicycle and pedestrian circulation on and around the campus;
7 requiring the institution or employment facility to include certain measures in
8 the facility master plan; and generally relating to bicycle and pedestrian access
9 at institutions of higher education and State employment facilities.

10 BY repealing and reenacting, with amendments,

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Transportation**

18 21–1008.

19 **(A)** By fiscal year 2000, each public institution of higher education and State
20 employment facility shall provide reasonable accommodations necessary for bicycle
21 access, including parking for bicycles.

22 **(B) BY FISCAL YEAR 2014, EACH PUBLIC INSTITUTION OF HIGHER**
23 **EDUCATION AND STATE EMPLOYMENT FACILITY SHALL DEVELOP A FACILITY**

1 MASTER PLAN THAT ADDRESSES BICYCLE AND PEDESTRIAN TRANSPORTATION
2 CIRCULATION:

3 (1) BETWEEN THE INSTITUTION OR EMPLOYMENT FACILITY AND
4 THE COMMUNITIES ADJACENT TO THE INSTITUTION OR EMPLOYMENT FACILITY;
5 AND

6 (2) WITHIN THE CAMPUS OF THE INSTITUTION OR EMPLOYMENT
7 FACILITY.

8 (C) THE FACILITY MASTER PLAN SHALL INCLUDE MEASURES THAT THE
9 INSTITUTION OR EMPLOYMENT FACILITY PROPOSES TO:

10 (1) INCORPORATE BIKEWAYS AND PEDESTRIAN FACILITIES ON
11 THE CAMPUS; AND

12 (2) PROMOTE BIKING AND WALKING ON THE CAMPUS.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 October 1, 2012.
