## A BILL ENTITLED

1 AN ACT concerning

2 **St. Mary's County – Alcoholic Beverages – Golf Course License**

3 FOR the purpose of authorizing the St. Mary's County Alcohol Beverage Board to  
4 issue a special Class M–G beer, wine and liquor license for use at a certain golf  
5 course; specifying that a licensee may be a golf course manager; providing for an  
6 annual license fee; specifying that the license may be used to sell beer, wine,  
7 and liquor for consumption only on the land and in the facilities used for golfing  
8 purposes; authorizing a golf course manager to designate an agent for certain  
9 purposes; authorizing the transfer of a Class M–G license under certain  
10 circumstances; requiring the Board to adopt certain regulations; exempting  
11 Class M–G licenses from a certain restriction; and generally relating to alcoholic  
12 beverages licenses issued in St. Mary's County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article 2B – Alcoholic Beverages**

21 **8–509.**

22 **(A) THIS SECTION APPLIES ONLY TO A GOLF COURSE THAT IS:**

23 **(1) LOCATED ON LAND THAT IS OWNED BY ST. MARY'S COUNTY;**

1           **(2) OPERATED BY A ST. MARY'S COUNTY GOLF COURSE**  
2 **MANAGER OR A GOLF COURSE MANAGER UNDER A MANAGEMENT AGREEMENT**  
3 **WITH ST. MARY'S COUNTY.**

4           **(B) (1) THE ST. MARY'S COUNTY ALCOHOL BEVERAGE BOARD MAY**  
5 **ISSUE A SPECIAL CLASS M-G BEER, WINE AND LIQUOR LICENSE FOR USE AT A**  
6 **MUNICIPAL GOLF COURSE.**

7           **(2) THE CLASS M-G LICENSE MAY BE ISSUED TO A GOLF COURSE**  
8 **MANAGER.**

9           **(C) THE ANNUAL LICENSE FEE IS \$600.**

10          **(D) A CLASS M-G LICENSE MAY BE USED TO SELL BEER, WINE, AND**  
11 **LIQUOR FOR CONSUMPTION ONLY ON THE LAND AND IN THE FACILITIES USED**  
12 **FOR GOLFING PURPOSES.**

13          **(E) (1) THE LICENSEE MAY DESIGNATE AN AGENT TO SELL BEER,**  
14 **WINE, AND LIQUOR AT THE GOLF COURSE.**

15          **(2) THE AGENT SHALL BE CONSIDERED THE VENDOR FOR**  
16 **COLLECTING AND REMITTING THE SALES AND USE TAX.**

17          **(F) ON REQUEST OF ST. MARY'S COUNTY, THE ST. MARY'S COUNTY**  
18 **ALCOHOL BEVERAGE BOARD MAY TRANSFER A CLASS M-G LICENSE TO A**  
19 **DIFFERENT GOLF COURSE MANAGER.**

20          **(G) THE ST. MARY'S COUNTY ALCOHOL BEVERAGE BOARD SHALL**  
21 **ADOPT REGULATIONS TO CARRY OUT THIS SECTION.**

22          SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
23 July 1, 2012.
