3 FOR the purpose of creating a Class BWL-MZ license for use at a zoo in a certain 4 location in Baltimore City; specifying that the license may be used to sell beer, 5 wine, and liquor for consumption only on the land and in the facilities used by the zoo; requiring an applicant who has another alcoholic beverages license to 6 7 exchange that license for a Class BWL-MZ license; requiring the Board of 8 Liquor License Commissioners for Baltimore City to take a certain action; 9 authorizing the licensee to designate an agent for a certain purpose; specifying 10 that the agent shall be considered the vendor for a certain purpose; authorizing the sale of beer, wine, and liquor at multiple locations under certain 11 12 circumstances; providing the hours of sale and the annual fee for the license; 13 authorizing the Board to adopt certain regulations; and generally relating to a Class BWL-MZ license for use at a zoo in Baltimore City. 14
