1 AN ACT concerning

State Board of Physicians – Exceptions from Licensing – Physicians Authorized to Practice Medicine by Another State

4 FOR the purpose of expanding a certain exception from licensing by the State Board of $\mathbf{5}$ Physicians to include a physician who resides in and is authorized to practice 6 medicine by any other state, instead of an adjoining state, and who meets 7 certain other requirements; establishing an exception from licensing by the 8 Board for a physician who resides in and is authorized to practice medicine in 9 another state and who provides medical services by telemedicine to a certain patient while the physician is in this State; defining a certain term; making 10 certain conforming changes; and generally relating to exceptions from licensing 11 12by the State Board of Physicians.

HOUSE BILL 1400

1 An individual while under the supervision of a licensed physician (5) $\mathbf{2}$ who has specialty training in psychiatry, and whose specialty training in psychiatry 3 has been approved by the Board, if the individual submits an application to the Board 4 on or before October 1, 1993, and either: $\mathbf{5}$ Has a master's degree from an accredited college or (i) 1. 6 university; and 72.Has completed a graduate program accepted by the 8 Board in a behavioral science that includes 1,000 hours of supervised clinical 9 psychotherapy experience; or 10 Has a baccalaureate degree from an accredited college (ii) 1. or university; and 11 122.Has 4,000 hours of supervised clinical experience that 13is approved by the Board. SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 1415October 1, 2012.
