## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Baltimore City –**  
3 **Renovation of Southeast Neighborhood Development Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010  
5 to extend the deadline for the Board of Directors of Southeast Development, Inc.  
6 to present evidence that a matching fund will be provided; requiring the Board  
7 of Public Works to expend or encumber the proceeds of the loan by June 1, 2013;  
8 and generally relating to an amendment to the Maryland Consolidated Capital  
9 Bond Loan of 2010.

10 BY repealing and reenacting, with amendments,  
11 Chapter 483 of the Acts of the General Assembly of 2010  
12 Section 1(3) Item ZA02(P) and Item ZA03(Q)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

19 (P) Southeast Neighborhood Development Center. Provide a

22 Southeast Development, Inc. for the renovation of the  
23 Southeast Neighborhood Development Center, located in  
24 Baltimore City. **NOTWITHSTANDING SECTION 1(5) OF THIS**
