A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt – Baltimore City – Miles Washington Family Support**
3 **Center**

4 FOR the purpose of authorizing the creation of a State Debt in the amount of
5 \$175,000, the proceeds to be used as a grant to the Board of Trustees of the
6 Miles Washington Family Support Center, Inc. for certain development or
7 improvement purposes; providing for disbursement of the loan proceeds, subject
8 to a requirement that the grantee provide and expend a matching fund;
9 requiring the grantee to grant and convey a certain easement to the Maryland
10 Historical Trust; establishing a deadline for the encumbrance or expenditure of
11 the loan proceeds; and providing generally for the issuance and sale of bonds
12 evidencing the loan.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That:

15 (1) The Board of Public Works may borrow money and incur indebtedness on
16 behalf of the State of Maryland through a State loan to be known as the Baltimore
17 City – Miles Washington Family Support Center Loan of 2012 in the total principal
18 amount of \$175,000. This loan shall be evidenced by the issuance, sale, and delivery of
19 State general obligation bonds authorized by a resolution of the Board of Public Works
20 and issued, sold, and delivered in accordance with §§ 8–117 through 8–124 of the State
21 Finance and Procurement Article and Article 31, § 22 of the Code.

22 (2) The bonds to evidence this loan or installments of this loan may be sold
23 as a single issue or may be consolidated and sold as part of a single issue of bonds
24 under § 8–122 of the State Finance and Procurement Article.

25 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
26 and first shall be applied to the payment of the expenses of issuing, selling, and

1 delivering the bonds, unless funds for this purpose are otherwise provided, and then
2 shall be credited on the books of the Comptroller and expended, on approval by the
3 Board of Public Works, for the following public purposes, including any applicable
4 architects' and engineers' fees: as a grant to the Board of Trustees of the Miles
5 Washington Family Support Center, Inc. (referred to hereafter in this Act as "the
6 grantee") for the planning, construction, repair, renovation, and capital equipping of
7 the Miles Washington Family Support Center, located in Baltimore City.

8 (4) An annual State tax is imposed on all assessable property in the State in
9 rate and amount sufficient to pay the principal of and interest on the bonds, as and
10 when due and until paid in full. The principal shall be discharged within 15 years
11 after the date of issuance of the bonds.

12 (5) Prior to the payment of any funds under the provisions of this Act for the
13 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
14 matching fund of \$50,000. No part of the grantee's matching fund may be provided,
15 either directly or indirectly, from funds of the State, whether appropriated or
16 unappropriated. No part of the fund may consist of in kind contributions. The fund
17 may consist of real property or funds expended prior to the effective date of this Act. In
18 case of any dispute as to the amount of the matching fund or what money or assets
19 may qualify as matching funds, the Board of Public Works shall determine the matter
20 and the Board's decision is final. The grantee has until June 1, 2014, to present
21 evidence satisfactory to the Board of Public Works that a matching fund will be
22 provided. If satisfactory evidence is presented, the Board shall certify this fact to the
23 State Treasurer, and the proceeds of the loan shall be expended for the purposes
24 provided in this Act.

25 (6) (a) Prior to the issuance of the bonds, unless the Maryland Historical
26 Trust determines that the property to be assisted by the grant is not significant, is
27 significant only as a contributing property to a historic district listed in the Maryland
28 register of historic properties, is a type that is already adequately represented among
29 the Trust's existing easement properties, or is already subject to a perpetual historic
30 preservation easement acceptable to the Trust, the grantee shall grant and convey to
31 the Maryland Historical Trust a perpetual preservation easement to the extent of its
32 interest:

33 (i) On the land or such portion of the land acceptable to the
34 Trust; and

35 (ii) On the exterior and interior, where appropriate, of the
36 historic structures.

37 (b) If the grantee or beneficiary of the grant holds a lease on the land
38 and structures, the Trust may accept an easement on the leasehold interest.

39 (c) The easement must be in form and substance acceptable to the
40 Trust, and the extent of the interest to be encumbered must be acceptable to the Trust,

1 and any liens or encumbrances against the land or the structures must be acceptable
2 to the Trust.

3 (7) The proceeds of the loan must be expended or encumbered by the Board
4 of Public Works for the purposes provided in this Act no later than June 1, 2019. If any
5 funds authorized by this Act remain unexpended or unencumbered after June 1, 2019,
6 the amount of the unencumbered or unexpended authorization shall be canceled and
7 be of no further effect. If bonds have been issued for the loan, the amount of
8 unexpended or unencumbered bond proceeds shall be disposed of as provided in
9 § 8–129 of the State Finance and Procurement Article.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 June 1, 2012.
