## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2011 – Montgomery County –**  
3 **Mental Health Association HVAC Replacement**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2011  
5 to allow the matching fund requirement for a certain grant to consist of real  
6 property, in kind contributions, and funds expended prior to a certain date;  
7 making this Act an emergency measure; and generally relating to amending the  
8 Maryland Consolidated Capital Bond Loan of 2011.

9 BY repealing and reenacting, with amendments,  
10 Chapter 396 of the Acts of the General Assembly of 2011  
11 Section 1(3) Item ZA02(AZ) and ZA03(AR)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
