8 (A) IN ANNE ARUNDEL COUNTY, A MEMBER APPOINTED TO THE 9 COUNTY BOARD BY THE GOVERNOR, THE COUNTY EXECUTIVE OF ANNE 10 ARUNDEL COUNTY, OR THE COUNTY COUNCIL OF ANNE ARUNDEL COUNTY 11 SHALL BE SELECTED FROM A LIST SUBMITTED TO THE APPOINTING AUTHORITY 12 BY THE SCHOOL BOARD NOMINATING COMMISSION FOR ANNE ARUNDEL 13 COUNTY UNDER § 3–110 OF THIS TITLE.

14 **(B)** THE ELECTED MEMBERS OF THE COUNTY BOARD SHALL BE 15 ELECTED IN ACCORDANCE WITH THE PROVISIONS OF TITLE 8, SUBTITLE 8 OF 16 THE ELECTION LAW ARTICLE GOVERNING THE ELECTION OF MEMBERS OF 17 COUNTY BOARDS OF EDUCATION.
