3 4 5 6	FOR the purpose of requiring the Secretary of State Police, on or before a certain date in each year succeeding the registration of a machine gun, to notify in writing the registrant of the requirement to renew the registration; and generally relating to the registration of machine guns.
7 8 9 10 11	BY repealing and reenacting, with amendments, Article – Criminal Law Section 4–403 Annotated Code of Maryland (2002 Volume and 2011 Supplement)
12 13	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
14	Article - Criminal Law
15	4–403.
16 17	(a) (1) A manufacturer of a machine gun shall keep a register of each machine gun manufactured or handled by the manufacturer.
18	(2) The register shall contain:
19 20	(i) the method of manufacture and serial number of the machine gun;
21 22	(ii) the date of manufacture, sale, loan, gift, delivery, and receipt of the machine gun from the manufacturer; and

1 2 3	(iii) the name, address, and occupation of the person to whom the machine gun was sold, loaned, given or delivered, or from whom the machine gun was received, and the purpose for which the machine gun was acquired.
4 5	(3) A person who violates this subsection is guilty of a misdemeanor and on conviction is subject to a fine not exceeding \$100.
6 7 8	(b) (1) On demand, a manufacturer of a machine gun shall allow a marshal, sheriff, or police officer to inspect the manufacturer's entire stock of machine guns, parts, and supplies and the register required under subsection (a) of this section.
9 10	(2) A person who violates paragraph (1) of this subsection is guilty of a misdemeanor and on conviction is subject to a fine not exceeding \$100.
11 12	(c) (1) (I) A person who acquires a machine gun shall register the machine gun with the Secretary of State Police:
13	[(i)] 1. within 24 hours after acquiring the machine gun; and
14	[(ii)] 2. in each succeeding year during the month of May.
15 16 17 18 19	(II) IN EACH SUCCEEDING YEAR AFTER THE INITIAL REGISTRATION OF A MACHINE GUN UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, ON OR BEFORE MARCH 15, THE SECRETARY OF STATE POLICE SHALL NOTIFY THE REGISTRANT IN WRITING OF THE REQUIREMENT TO RENEW THE REGISTRATION.
20 21	(2) The Secretary of State Police shall prepare and, on request of an applicant, furnish an application form for registration under this subsection.
22	(3) An application for registration shall contain:
23 24	(i) the make, model, serial number, caliber, type, barrel length, finish, and country of origin of the machine gun;
25 26 27	(ii) the name, address, race, gender, date of birth, Maryland driver's license number, and occupation of the person in possession of the machine gun; and
28 29	(iii) the name of the person from whom the machine gun was acquired and the purpose for acquiring the machine gun.
30	(4) Each application for registration filed with the Secretary of State

Police shall be accompanied by a nonrefundable registration fee of \$10.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 4 October 1, 2012.
