A BILL ENTITLED

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages Licenses – Class C–3 Club License**

3 FOR the purpose of removing the requirement in Harford County for a country club to
4 maintain a certain number of tennis courts to be eligible for a Class C–3 club
5 alcoholic beverages license; and generally relating to eligibility for a Class C–3
6 club alcoholic beverages license in Harford County.

7 BY repealing and reenacting, with amendments,
8 Article 2B – Alcoholic Beverages
9 Section 6–301(n)(6)
10 Annotated Code of Maryland

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article 2B – Alcoholic Beverages**

15 6–301.

16 (n) (6) (i) In this paragraph the following words have the meanings
17 indicated.

18 1. “Miscellaneous organization or club” means a country
19 club, a yacht or boat club, or topiary garden.

20 2. “Country club” means a club or organization that:

21 A. May be operated for profit or not for profit;

1 B. Has 75 or more bona fide members each of whom pays
2 not less than \$50 per year; and

3 C. Maintains at the time of the application for the
4 license and continues to maintain a regular or championship golf course of 9 holes or
5 more, or, instead of the golf course, a swimming pool at least 20 by 40 feet in size[, and
6 at least 6 tennis courts].

7 3. “Topiary garden” means an organization that:

8 A. Operates a public museum and garden for its
9 membership and the general public as guests of the membership;

10 B. Is open to the general public for at least 6 days a week
11 for at least 6 hours a day during 5 months each year; and

12 C. Has food preparation facilities on the topiary garden
13 premises for the convenience of visiting guests.

14 4. “Yacht or boat club” means a club or organization
15 that:

16 A. May be operated for profit or not for profit;

17 B. Owns real property in Harford County; and

18 C. Has not less than 150 bona fide dues-paying members
19 and not less than 50 of whom own a yacht, boat, or other vessel.

20 (ii) A Class C–3 license may be issued only to a miscellaneous
21 organization or club.

22 (iii) 1. The fee for a 6-day, Monday through Saturday,
23 (on-sale) Class C–3 license under this paragraph is \$1,300.

24 2. The fee for a 7-day Class C–3 license under this
25 paragraph is \$1,400.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 July 1, 2012.
