15 16	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

19 20	(a) (1) A principal political party shall elect the members of the county central committee at a primary election.			
21 22 23	(2) Except as otherwise provided in this section or § 4–203 of this subtitle, the central committee for a county shall consist of the number of members determined by the party's constitution.
