Occupational and Professional Licensing Design Boards - Sunset Provisions and Program Evaluation

- 4 FOR the purpose of continuing the State Board of Certified Interior Designers in $\mathbf{5}$ accordance with the provisions of the Maryland Program Evaluation Act (sunset 6 law) by extending to a certain date the termination provisions relating to the 7 statutory and regulatory authority of the Board; requiring that an evaluation of 8 the Board and the statutes and regulations that relate to the Board be 9 performed on or before a certain date; repealing certain termination provisions relating to the Occupational and Professional Licensing Design Boards' Fund 10 and the authority of certain occupational and professional licensing design 11 12boards to set fees; and generally relating to the occupational and professional 13 licensing design boards.
