That the Laws of Maryland read as follows: 15 Article - Criminal Law 10-604. 16 [A] EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, A 17 (a) 18 person may not: 19 overdrive or overload an animal; (1) 20 **(2)** deprive an animal of necessary sustenance; 21(3) inflict unnecessary suffering or pain on an animal;

- [(b)] (C) (1) A person who violates this section is guilty of a misdemeanor and on conviction is subject to imprisonment not exceeding 90 days or a fine not exceeding \$1,000 or both.
- 14 (2) As a condition of sentencing, the court may order a defendant 15 convicted of violating this section to participate in and pay for psychological 16 counseling.
- 17 (3) As a condition of probation, the court may prohibit a defendant from owning, possessing, or residing with an animal.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2012.
